This solicitation amendment has been raised to provide answers to questions posed by potential bidders:

Question 1: What hours the contractor is allowed to work?

Answer 1: 10 hours/day& 7 days a week is acceptable.

Question 2: Is there any sequence to the construction, i.e. which gate can be worked on or can both be worked on at same time?

Answer 2: Preferred exterior gate to be worked on first; security wants the opening to be enclosed with a bi-fold gate that can be closed and locked each night after all construction workers leave. The bi-fold gate can be constructed of chain link fence material. The important this is for the framing to be attached to the existing wall to prevent anyone gaining access between the security gate and the wall and gain access to the outside.

Question 3: Will there be a place for a lock box/cCAN for daily used tools/material/lay down area for material and where will it be? Outside wall/inside wall?

Answer 3: A lay down area and lockbox/cCan will be accommodated in the immediate enclosure north of ss gate to be removed. Only site lines from Unit6 through to PFV need to be maintained.

Question 4: Scaffolding will be required, does it need to be removed each day or can it stay in place? The construction area will mean the SS gate will be down and open for a length of time. What is the security requirements?

Answer 4: Scaffolding does not need to be removed daily.

Question 5: Where will they sign in and have their passes? This will essentially be a restricted work site.

Answer 5: Sign is in at the scanner area each time the contractor enters or leaves the site.

Question 6: How will the control for the armed guard from the gallery in C24 be handled? Right now everyone has to be behind a fence when he passes through.

Answer 6: Security will be determined to ensure the contractor is not stopped during this operation.

Question 7: Are there any special requirements for the control tower when they need access to it to tie in controls?

Question 7: This needs to be coordinated with Unit 6 staff when it is required.

Question 8: What happens when the PFV is occupied?

Answer 8: The security will be monitored by a commissionaire to ensure nothing is passed through fencing to contractors and visa/versa.

Question 9: How will food truck/anything else be delivered to Unit 6?
