This Solicitation Amendment 001 is raised to incorporate responses to questions from potential bidders.

**Questions and Answers for North Apron Remediation (EZ897-161031/A)**

Q1: What are the dimensions of the excavation including depth?

A1: The dimensions of the excavation may be determined using Drawing 3, and the scale bar provided in the drawing. These are the target limits for the contamination at 6 to 6.7 m in depth; the contractor will have to determine the final excavation area, based on discussion with their geotechnical engineer and their designed side slopes, based on their proposed shoring plan. The maximum depth of excavation is approximately 6.7m.

Q2: Are the storm and sanitary lines pressurized? If so, what is the pressure?

A2: Observations from the manhole suggest the service lines are draining by gravity, please it note it is up to the bidder to verify all information regarding site conditions.

Q3: What is the depth below grade of the storm and sanitary line?

A3: The exact depth below grade of the storm and sanitary line is not known. In Drawing 9, it states that the contractor must verify all information including, but not limited to, location, size, type, depth of all service lines. The line is likely to be located within the hydrocarbon impacted layer that exists between 4 and 6.7m below the existing ground surface.

Q4: What is the sanitary and sewer line constructed of? What year were they originally constructed?

A4: The year of construction, and the construction materials of the sanitary and sewer line are not known. The City of Whitehorse may be able to provide these details.

Q5: On the North Apron Utilities Map, what is in the u/g pipeline that appears to be in the proposed remedial excavation? What is the size of the u/g pipeline?

A5: The contents and size of the u/g pipeline are not known. The utility information was provided to ARCADIS by several third parties and we have provided the available information. We do not have any additional details, nor have we verified any of the information provided.
