The following changes, additions, and/or deletions are hereby made a part of the Contract Documents for R.M. of Bratts Lake, Decommissioning of Baseline Surface Radiation Network Facility as fully and completely as if the same were fully set forth therein:

Questions received during tender period have been clarified in the following attachments.

1 Questions received electronic submission

1. Drawing C-002 Detail A, there is no depth for the trench. Is there an approximate depth (H)?

Answer:

There are no As-Built drawings for the cabling between project areas. It is thought that the cabling is buried approximately 3 feet deep.

2. What is the conduit size in the pipe zone in the trench?

Answer:

See Addendum TWO – Unknown.

3. How many conductors and sizes are in each conduit?

Answer:

Unknown.

4. Is the land the buildings and tower are on, leased farm land? Will work to commence after harvest is complete?

Answer:

See Addendum TWO - The Government of Canada will be responsible to negotiate, and pay for, crop loss that occurs within the construction limits identified on the drawings.

See Section 01 11 00 Work Sequence.

5. In the specifications, the buildings are to be removed by others. Who would the contract be for building removal? Are the buildings available?

Answer:

See Addendum TWO - For description of work to be included in contract see Specification Document, Section 01 11 00 and Addendum #001.

Area 1 removal work covered in contract is described in specification. Site cleanup of Area 1, in consideration of Addendum #001, is to be completed after all buildings as described in specification, have been removed by contractor.

See Specification Document for description of work covered by contract documents. Buildings not listed for removal are not available for purchase, removal, salvage etc. within the work covered by contract documents.

6. In Annex B there is mention of the land owner, do you have contact information, we would like to know the distance from the project site to the soil location.

Answer:

Contact information for the land owner will be released to contractor when contract is awarded. Contractor will be required to secure agreement for soil, an agreement is not currently in place. It is anticipated that the landowner would like to make soils available from lands in close proximity to the site.
