QUESTIONS AND ANSWERS

Question 1

There is a clauses in page 16 regarding professional licenses in four provinces in Canada. We have only one P.Eng who is licensed in Ontario and Quebec. All other senior team members are licensed in various US states. All our team members (US PE) are qualified and willing to get a temporality licenses in the four Canadian provinces. Do we need to have all senior engineers being licensed in one or more of the four Canadian provinces prior to submit the proposal? Is it enough at this stage to present one P.Eng in Ontario/Quebec and other PE licensed in US?. We are willing and qualified to become licensed in the province in which we will provide service.

Answer 1

The Supplier must be an engineer licensed in the Province of Nova Scotia and/or New Brunswick and/or Prince Edward Island and/or Newfoundland and Labrador.

"Supplier" means the person or entity (or, in the case of a joint venture, the persons or entities) submitting an arrangement. It does not include the parent, subsidiaries or other affiliates of the Supplier, or its subcontractors.

Question 2

Do we need to have a presence in one of the four provinces, i.e. office in Canada?

Answer 2

No, it is not a condition of the qualification process that suppliers have a local office for the geographic regions they wish to propose services, however, travel to the project location and a requirement for a local project office may be required for specific projects. Travel expenses, including travel time, and the requirement for a local project office must be included in the supplier's fees and will not be reimbursed separately. Specific details regarding project travel and the requirement for a local project office would be detailed in the project specific Required Services included in the solicitation issued against the Supply Arrangement. Please reference Part 6C 1(b) Resulting Contract Clauses, R1230D, GC5.12.

Note for 5.1.1: Where a Proponent or its Affiliate is **unable to certify that it has not been convicted of any of the offences** referenced under the Canadian Offences Resulting in Legal Incapacity, the Canadian Offences and the Foreign Offences subsections, **the Proponent must provide with its bid the completed Declaration Form** (<http://www.tpsgc-pwgsc.gc.ca/ci-if/formulaire-form-eng.html>), to be given further consideration in the procurement process.

All other terms and conditions remain the same.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION (REVISED AS PER AMD 002)

Suppliers must provide the required certifications and additional information to be issued a supply arrangement (SA).

The certifications provided by Suppliers to Canada are subject to verification by Canada at all times. Canada will declare an arrangement non-responsive, or will declare a contractor in default if any certification made by the Supplier is found to be untrue whether made knowingly or unknowingly during the arrangement evaluation period, or during the period of any supply arrangement arising from this RFSA and any resulting contracts.

The Supply Arrangement Authority will have the right to ask for additional information to verify the Supplier's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Supply Arrangement Authority will render the arrangement non-responsive, or constitute a default under the Contract.

5.1 Certifications Required with the Arrangement

Suppliers must submit the following duly completed certifications as part of their arrangement.

5.1.1 Declaration of Convicted Offences

***As applicable,** pursuant to subsection Declaration of Convicted Offences of section 01 of the Standard Instructions, the Supplier must provide with its arrangement, a completed Declaration Form (<http://www.tpsgc-pwgsc.gc.ca/ci-if/formulaire-form-eng.html>), to be given further consideration in the procurement process.*

5.2 Certifications Precedent to the Issuance of a Supply Arrangement and Additional Information

The certifications and additional information listed below should be submitted with the arrangement, but may be submitted afterwards. If any of these required certifications or additional information is not completed and submitted as requested, the Supply Arrangement Authority will inform the Supplier of a time frame within which to provide the information. Failure to provide the certifications or the additional information listed below within the time frame provided will render the arrangement non-responsive.

5.2.1 Integrity Provisions – List of Names

Suppliers who are incorporated, including those submitting an arrangement as a joint venture, must provide a complete list of names of all individuals who are currently directors of the Supplier.

Suppliers submitting an arrangement as sole proprietorship, as well as those submitting an arrangement as a joint venture, must provide the name of the owner(s).

Suppliers submitting an arrangement as societies, firms or partnerships do not need to provide lists of names.
