1. Questions and Answers 1:

Canada

QUESTION 1:

I was concerned about a quote per participant for the entire program, when the length of the program is not stipulated other than "up to six weeks". This would force us to propose the highest possible cost to make sure our costs are covered, in other words, our cost for a six week program, in our proposal. If CORCAN subsequently asked for a four week course, they would be obliged to pay the six week cost which isn't really fair to them.

Answer 1:

Scaffolding courses may have a varied required length and/or content, dependant on the province of instruction. Please ensure that your proposed course content and/or length reflects the minimum provincial requirements where time spent in the program will be recognized towards an apprenticeship program within the province of delivery. Courses that are more than six weeks long in duration will not be accepted.

Proposals submitted are to be based on the 'Cost per Student', for the length of program that would be offered to meet the minimum provincial requirement towards an apprenticeship program within that province of delivery.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
