This amendment is raised to answer questions from potential bidders.

Q1. By the look of the specifications for the fabric in Annex B, Section 3.5.1 – Body Fabric, there has been a decision on fabric composition. Has a specific fabric vendor been identified as the preferred vendor? If so, who is that vendor?

A1. No vendor has been decided. Requirements are inclusive of multiple, varied possibilities.

Potential bidders were made aware of draft requirements in our LOI/RFI; final requirements have not deviated significantly from those that were originally proposed. It is acknowledged that development work might be required by some companies, but it is believed that there are existing fabrics capable of meeting the requirements.

Q2 There is a reference in section 3.5.1 of no more than 40% Thermoplastic content. However in the technical specifications Annexe B there is a requirement for no melt no drip. There is a contradiction between these two notions. Please advise.

A2. Compliance to the no-melt no-drip requirement is dependent on fibre(s) used, yarn construction and fabric construction. However, there is no contradiction. Thermoplastic fibres are not required, however, if used, the content of thermoplastic fibres in a fibre blend cannot be greater than 40% (it doesn't have to be 40%, it must be less, or not at all).

Q3. In 3.51.2 Grey is the required color. How can we see the actual color required as there are many different greys?

A3. One specific shade of grey is not required. Para 3.5.1.2 defines acceptable shade ranges.

Q4. Is there a fly on the required model of men's under wear

A4. Yes. See Annex B, paragraph 3.4.2.

Q5. In Annex B there are specific % on stretch requirements . How have these specific percentages on the fabric been derived? Is there a particular fabric blend content that the navy is interested in?

A5. No specific blend is required or specified. Stretch values were derived from numerous sources including but not limited to information and samples received in response to the published LOI/RFI.

All other terms and conditions remain the same.
