Amendment 001 has been raised to answer questions from potential bidders.

Q1. Please confirm if proponents must be currently licensed to operate in Yukon or if they need to be eligible to obtain licensing.

A1. Proponents must be eligible to obtain licensing to operate in Yukon. Proponents are reminded for BC they must be licensed.

Q2. Please confirm that a Procurement Business Number (PBN) is not required at submission

A2. A PBN is not required at submission; however, will be required for the successful proponent(s).

Q3. Under 3.2.2.1 and 3.2.2.3 in Rated requirements the term “demonstrate application of public processes and practices” is used. This is broad and vague and can mean a number of different things. Can further explanation of this term in the context of this proposal be provided for respondents?

A3. No additional explanation will be provided.

Q4. 3.2.3 Senior Personnel - What minimum number of years of experience is required of a senior personnel if any?

A4. AEC industry accepted standard is 10 years.

Q5. 3.2.4 Project Personnel - What minimum number of years of experience is required of a Project personnel if any?

A5. No additional explanation will be required.

Q6. 3.2.2.1 Project Experience - Is previous experience on the mentioned typologies (offices, border crossing, laboratories and light industrial buildings) a prerequisite? If example projects are not used will this be used to score against proponents?

A6. Previous experience on mentioned typologies is not a prerequisite, if project + experience is deemed applicable it will be used to improve but not penalize a score.

Q7. 3.2.2 Further to the above, is previous PWGSC/Federal experience a prerequisite and will specifying or using PWGSC projects be seen as adding to the proposal score?

A7. Previous experience on mentioned typologies is not a prerequisite, if project + experience is deemed applicable it will be used to improve but not penalize a score.

Q8. 3.2.2.1 Project Experience: Design & 3.2.2.2 Project Experience: Process
