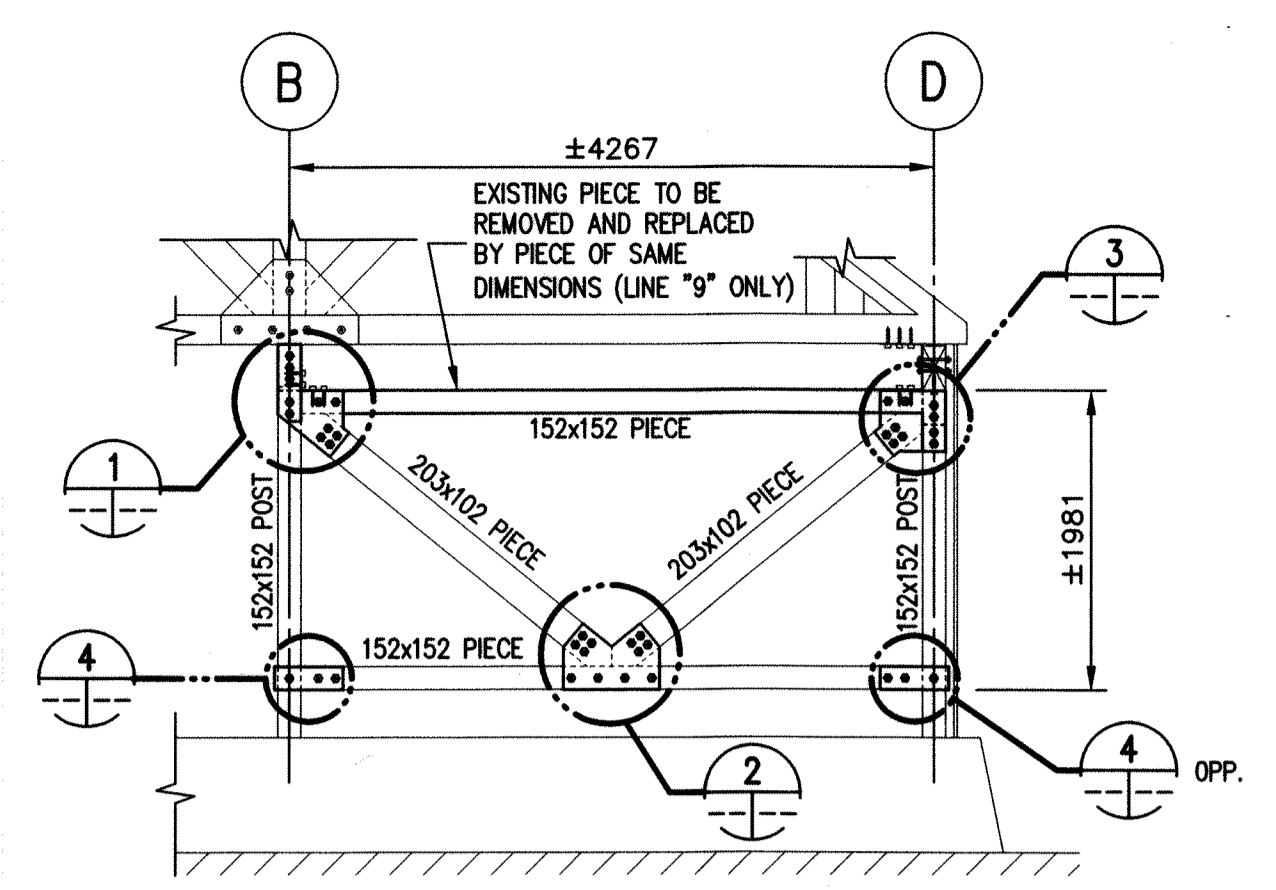
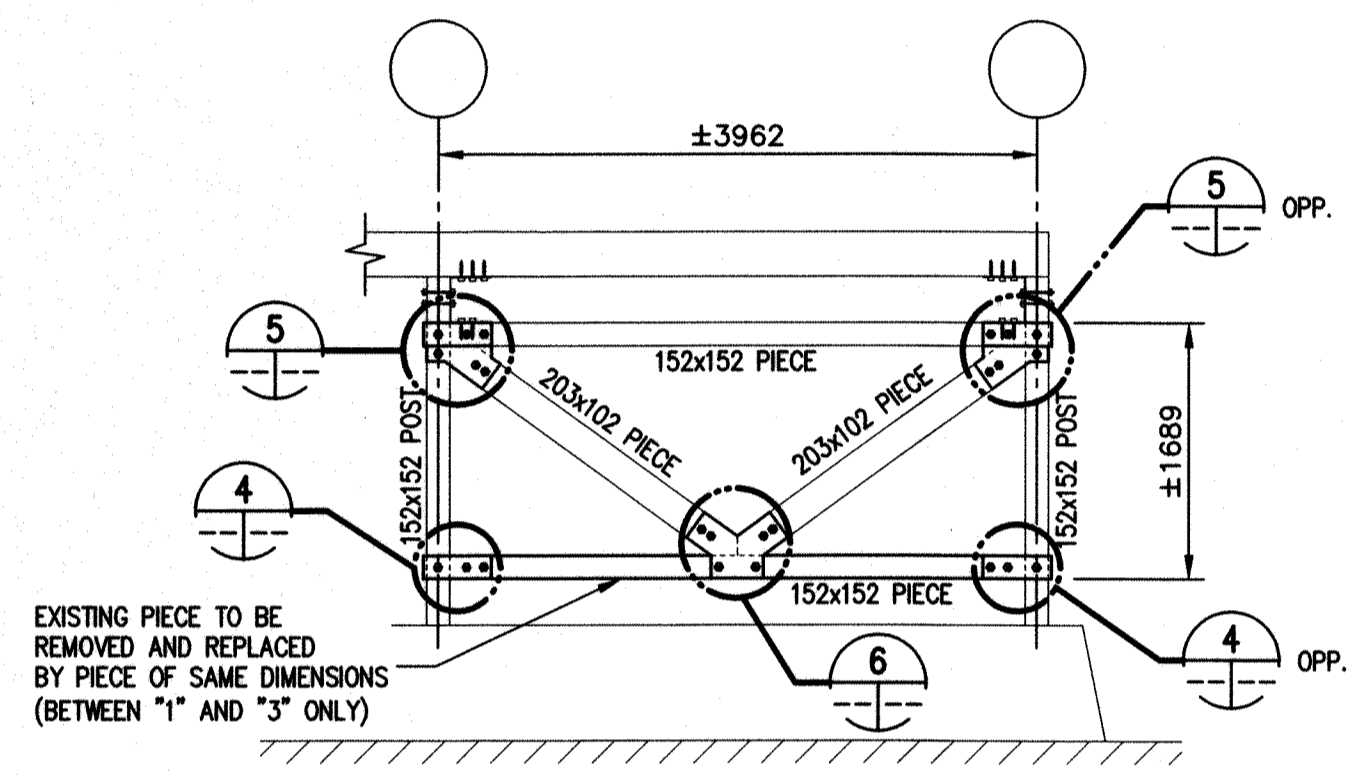


PLAN VIEW - ESKER BUILDING

GENERAL REQUIREMENTS

ALL WORKS SHALL MEET THE REQUIREMENTS OF THE "CODE DE CONSTRUCTION DU QUÉBEC - CHAPITRE 1, BÂTIMENT, ET CODE NATIONAL DU BÂTIMENT - CANADA 2005 (MODIFIÉ)", (QUÉBEC VERSION OF CNBC)

ON-SITE, THE CONTRACTOR SHALL VERIFY ALL DIMENSIONS AND LOCATIONS SHOWN ON DRAWINGS. THE CONTRACTOR SHALL ALSO VERIFY ALL MEASUREMENTS OF THE NEW CONSTRUCTION BEFORE ANY FABRICATION. FOLLOWING THESE VERIFICATIONS, NOTIFY THE OWNER OF ANY MODIFICATIONS REQUIRED ON DRAWINGS.

THE CONTRACTOR SHALL TAKE ALL NECESSARY PRECAUTIONS TO RESPECT THE FIRE PROTECTION AND HEALTH-SECURITY RULES OF THE OWNER.

THE CONTRACTOR SHALL COORDINATE WORKS WITH ALL BUILDING TRADES.

THE CONTRACTOR IS RESPONSIBLE FOR THE DISTRIBUTION OF GENERAL NOTES TO EACH OF ITS SUBCONTRACTORS DURING TENDER AND CONSTRUCTION PHASES.

WITH THE OWNER, VERIFY THE BUILDING, CABLES, PIPES AND ALL OTHER SERVICES WHICH COULD BE DAMAGED DURING WORK. THE CONTRACTOR SHALL REPAIR ANY DAMAGES AT HIS OWN EXPENSES.

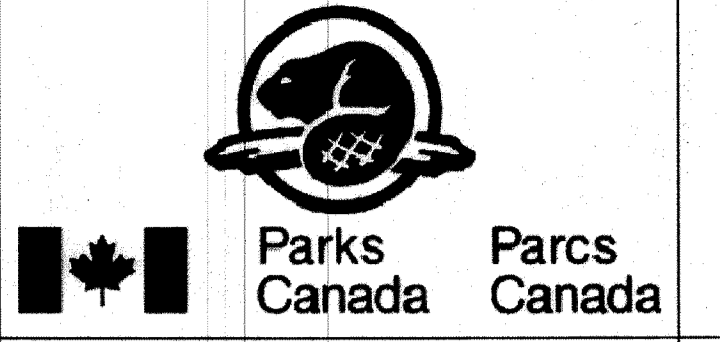
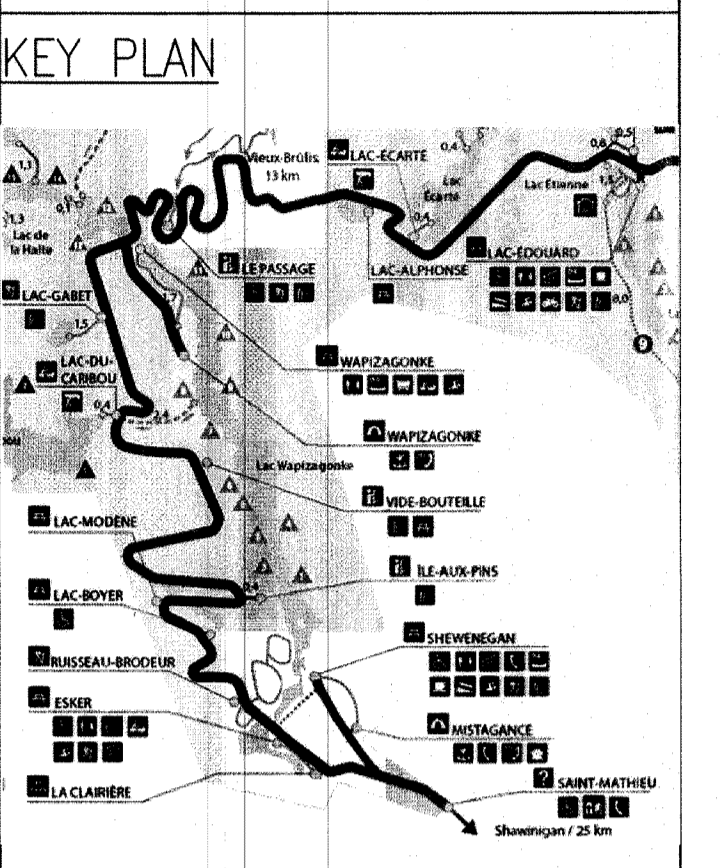

- CONSTRUCTION WOOD : SPECIES S.P.F. NO. 1/NO. 2 (FOR STUDS AND LIGHT FRAMING PIECES) AND S.P.F. NO. 1 (FOR BEAMS AND COLUMNS), CONFORM TO CAN/CSA 0141. ALL WOOD SHALL BE DRIED AND SHALL BE UNDER 19% MOISTURE CONTENT WHEN PUT IN PLACE.
- PLYWOOD : DOUGLAS FIR, CONFORM TO 0121-08.
- BOLTS : CONFORM TO ASTM A307-14, WITH HEXAGONAL HEAD, WASHER AND NUT. THREADED RODS ARE NOT ACCEPTED.
- NAILS : CONFORM TO CSA B111.
- CONNECTION PLATES : 640.21-300W STEEL, HOT DIP GALVANIZED AFTER FABRICATION.
- WELDING FOR CONNECTION PLATES, ACCORDING TO W59-13, WITH E49XX ELECTRODES.
- STAIN AND PAINT : SEE ARCHITECTURE.

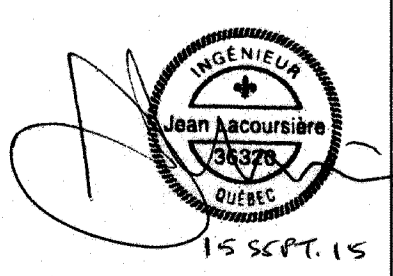
