Part 1 General

1.1 GENERAL REQUIREMENTS

- A. This Addendum shall be attached to the Specifications and Drawings and shall form an integral part of the Contract Documents. The contents of this Addendum shall be brought to the attention of all concerned.

Part 2 Specifications

2.1 Section 01 11 00: Summary Of Work

1. **Clarification:** What are the hours of work?

Item 1.3 - Work Sequence

.5 Work shall be completed between 630am to 530 pm Monday to Friday.

.1 Unless prior approval, all disruptive work shall be completed during after hours.

.2 The contractor is responsible for obtaining and paying for a Commissionaire from the Corp of Commissionaire for all after hours work.

2. **Clarification:** Are we running conduit?

Item 1.1 - Work Covered By Contract Documents

AH .8 – ITAX .7 All cabling, conduit and cable tray to be new. Contractor may reuse conduit or cable tray if it is assessed by the Departmental Representative to meet all applicable standards and is in compliance with the contract specifications and drawings. Written approval must be given by Departmental Representative in order to proceed with any reuse.

AH .9 – ITAX .8 Cabling installed within the building interior (excluding the parkade) is to be run within new EMT conduit or new common cable tray. Cabling installed within the parkade must be run within new RGS conduit. Cabling installed exterior to the building must be run within new RGS conduit. Ensure cabling and conduits are concealed for all interior installations unless approved by Departmental Representative. Parkade and exterior conduit to be concealed as much as possible. All exposed

conduit to be painted to match existing building construction. Paint colour and type to be approved by Departmental Representative before supply and installation of any materials.

3. **Clarification:** What How will the ITAX system connect into the Alvin Hamilton network?

Item 1.1 - Work Sequence

AH .5 The system shall be capable of communicating, in its entirety, using the same communication protocols, and be of the same manufacturer as the system being installed at 1955 Smith Street, Regina, Saskatchewan, ITAX Building. The Alvin Hamilton building is designated as the primary monitoring station. This system shall be able to monitor the ITAX building in its entirety, at full resolution. Coordinate, with the Departmental Representative, the data/internet connection required for proper communications of the two systems, ensuring to include a thirty percent future expansion of the systems. The Crown shall be responsible for any costs associated with the data/internet connection upgrade.

ITAX .4 The system shall be capable of communicating, in its entirety, using the same communication protocols, and be of the same manufacturer as the system being installed at 1783 Hamilton Street, Regina, Saskatchewan, Alvin Hamilton Building. The ITAX building is to be monitored from the Alvin Hamilton building. This system shall be able to be monitored by the Alvin Hamilton building system in its entirety, at full resolution. Coordinate, with the Departmental Representative, the data/internet connection required for proper communications of the two systems, ensuring to include a thirty percent future expansion of the systems. The Crown shall be responsible for any costs associated with the data/internet connection upgrade.
