FQS-33 Condiments and Condiment Sauces

Description:

A condiment is an edible substance such as a sauce or seasoning added to food to enhance the flavour of the food. Condiments include products such as Chili Sauce, Catsup, Soya Sauce, Horseradish, Relish, Mustard, Salsa, etc. Table 1.0 provides specifications for some common condiments. The range of condiments available are too numerous to provide detailed specifications for all products available. Condiments with Canadian Regulations specific to them are indicated in Table 1.0. Condiments listed in Table 1.0 and all other condiments procured must meet the requirements listed below.

Condiment	Specifications	Grade
Tomato Catsup, Catsup	Catsup is made from the juice of red-ripe tomatoes or sound tomato trimmings from which skins and seeds have been removed. Must meet the specifications as indicated in Canada Agricultural Products Act - Processed Products Regulations - Schedule 1- Table 1 para. 60.	Canada Fancy
Tomato Chili Sauce	Tomato Chili Sauce is made from chopped or crushed, well-ripened whole tomatoes with peelings screened out. A substantial portion of the seeds remain in the product. Vinegar, salt, seasoning and sweetener is added. Must meet the specifications as indicated in Canada Agricultural Products Act - Processed Products Regulations - Schedule 1- Table 1 para. 61.	Canada Fancy
Relish, Sweet Relish, Pickles or Chutney	Products prepared from clean sound vegetables or fruits and salt and vinegar and meeting the specifications as indicated in Canadian Agricultural Products Act-Processed Products Regulations Schedule II para 38.	

All condiments and condiment sauces procured in Canada:

- must be of the type and size indicated;
- must comply with [Canada Agricultural Products Act - Processed Products Regulations](#);
- must comply with the specifications as indicated in Table 1 (where applicable) and the section of Canada Agricultural Products Act - Processed Products Regulations indicated in Table 1.0;

- must comply with all other relevant sections of Acts and Regulations listed under [Canada Food and Drugs Act](#), [Food and Drug Regulations](#), [Canada Agricultural Products Act](#) and [Related Regulations](#), and [Canadian Food Inspection Agency Act](#);
- must comply with fundamental principle related to Health and Safety listed under [Canada Agricultural Products Act - Processed Products Regulations](#);
- must comply with the relevant sections listed under [Canadian Food Inspection Agency - Food Safety](#); must comply with food additive regulations listed under [Food and Drug Regulations - Division 16](#);
- must comply with food packaging and labelling requirements listed under [Consumer Packaging and Labelling Act](#), and [Consumer Packaging and Labelling Regulations](#);
- must comply with the relevant sections listed under, [Canadian Food Inspection Agency - Guide to Food Labelling and Advertising](#);
- must be prepared and handled in accordance with essential principles of food hygiene applicable throughout the food chain (including primary production through to the final consumer), ensuring that food is safe and suitable for human consumption listed under - [Recommended International Code of Practice - General Principles of Food Hygiene - CODEX ALIMENTARIUS](#), including Annex on Hazard Analysis and Critical Control Point (HACCP) system and guidelines;
- must comply with any microbiological criteria established in accordance with the Principles for the Establishment and Application of Microbiological Criteria for Foods (CAC/GL 21-1997).

All condiments and condiment sauces procured outside Canada:

- must only be procured from countries that meet federal acts and regulations govern the importation of food under [Canadian Food Inspection Agency - Guide to Importing Food Commercially](#)
- be of the type and size indicated;
- must comply with [Canada Agricultural Products Act - Processed Products Regulations](#) (or the equivalent in the country where procured);
- must comply with the specifications as indicated in Table 1 (where applicable) and the section of [Canada Agricultural Products Act - Processed Products Regulations](#) indicated in Table 1.0;
- must only be procured from countries that meet federal acts and regulations govern the importation of food under [Canadian Food Inspection Agency - Guide to Importing Food Commercially](#);
- must comply with relevant sections of Acts and Regulations (or the equivalent in the country where procured) listed under [Canada Food and Drugs Act](#), [Food and Drug Regulations](#), [Canada Agricultural Products Act](#) and [Related Regulations](#), and [Canadian Food Inspection Agency Act](#);

- must comply with fundamental principle related to Health and Safety listed under [Canada Agricultural Products Act - Processed Products Regulations](#);
- must comply with the relevant sections listed (or the equivalent in the country where procured) under [Canadian Food Inspection Agency - Food Safety](#);
- must comply with food additive regulations listed under [Food and Drug Regulations - Division 16](#); and/or
- must comply with food additive classes listed under [General Standard for Food Additives \(Codex Stan 192-1995\)](#);
- must comply with food packaging and labelling requirements listed under [Consumer Packaging and Labelling Act](#) and [Consumer Packaging and Labelling Regulations](#); and/or
- must comply with the relevant sections listed under, [Canadian Food Inspection Agency - Guide to Food Labelling and Advertising](#); and/or
- shall comply with all the requirement listed under [General Standard for the Labelling of Prepackaged Foods \(Codex Stan 1-1985\)](#);
- must be prepared and handled in accordance with essential principles of food hygiene applicable throughout the food chain (including primary production through to the final consumer), ensuring that food is safe and suitable for human consumption listed under - [Recommended International Code of Practice - General Principles of Food Hygiene - CODEX ALIMENTARIUS](#), including Annex on Hazard Analysis and Critical Control Point (HACCP) system and guidelines;
- must comply with others relevant Codes of Hygienic Practice and Codes of Practice recommended by the Codex Alimentarius Commission relevant to condiments or condiment sauces;
- must comply with all the requirement listed under [Guidelines for the Use of Flavours \(Codex CAC/GL 66-2008\)](#);
- must comply with any microbiological criteria established in accordance with the Principles for the Establishment and Application of Microbiological Criteria for Foods (CAC/GL 21-1997); and
- meet all requirements of applicable local food legislation whenever those requirements are stricter. All condiments and condiment sauces shall be obtained by sources approved by the applicable local and international laws, regulations, procedures and requirements.

Packaging:

Condiment sauce shall be packaged in normal retail and commercial packaging, packing, labelling and marking which safeguard the hygienic, nutritional, technological and organoleptic qualities of the food. Packaging must be made of substances which are safe and suitable for their intended use and does not impart any toxic substance or undesirable odour or flavour to the product.
