#### **1. Respond to Questions**

##### **Question # 1**

**Reference:** Section 8.2.1 – Search Operator - The contractor must provide a Search Operator (qualified advanced SSE – (Sensitive Site Exploitation)) who has: a minimum experience of one combat tour in support of a SOF organization.

The Bidder must propose a Search Operator who is qualified Advanced Sensitive Site Exploitation (SSE) with a minimum of: One combat tour in direct support of a Special Operations Forces (SOF) organization in a theatre of operations. Resume/CV clearly indicating education, training, employment, qualifications, certification, etc related to SOF and SSE. Documented proof of Advanced SSE qualification

**Question:** For the Search Operator qualifications and certifications, other than the one combat tour in direct support of a Special Operations Forces qualification, can specifics be identified for the documented proof of Advanced SSE qualification, i.e. SSE courses attended, similar EOD courses, or will experience as an SSE instructor meet the documentation requirement, etc.?

##### **Answer # 1**

Either SSE courses attended (British or U.S. certification) or experience as an SSE instructor would meet this requirement

##### **Question # 2**

**Reference:** Section 8.2.1 – Search Operator - The contractor must provide a Search Operator (qualified advanced SSE – (Sensitive Site Exploitation)) who has: a minimum experience of one combat tour in support of a SOF organization.

The Bidder must propose a Search Operator who is qualified Advanced Sensitive Site Exploitation (SSE) with a minimum of: One combat tour in direct support of a Special Operations Forces (SOF) organization in a theatre of operations. **Question:** It is unclear within the Statement of Work description of the course phases (1-3) on where instruction is to be provided for SSE and advanced electronics. Is it possible to receive clarification of these modules of instruction and which course phase it is to be provided?

I see this being taught during phase 2 and practiced during phase 3 however, it will be best determined by the bidder in which phase on/during curriculum creation.
