Amendment to Annex "A", Statement of Work

Section 011005, General Instructions

4. CLEANING SUPERVISORS

Delete:

.1 A minimum of two full time supervisors must be on site full time during normal hours of operation under the direction of the Superintendent of Cleaning Services. Supervisors will each be responsible for supervising the cleaning of no more than 20,000 m2 of area. All Work will be under supervision. Supervisors must not be part of the Janitorial Personnel as they must at all times only perform their supervisory duties.

Insert:

.1 A minimum of two full time supervisors must be on site full time during normal hours of operation under the direction of the Superintendent of Cleaning Services. Supervisors will each be responsible for supervising the cleaning of no more than 20,000 m2 of area. All Work will be under supervision. Supervisors may perform cleaning tasks.
