Here are the questions which we have received until now:

Question 1: Reference: Annex A, Section A.11, Specification # 1 (Engine of 74 HP):
Is it a gross power or net power?

Answer 1: It is a gross power.

Question 2: Reference: Annex A, Section A.11, Specification # 3 (Bucket):
Do you accept a bucket of 84 or 96 inches instead of 88 inches?

Answer 2: We accept a bucket between 84 and 88 inches. The specification # 3 is amended as follows:

- delete: ~~88-inch~~ general-purpose bucket.
 - insert: General-purpose bucket, between 84 (minimum) and 88 (maximum) inch wide.

Question 3: Reference: Annex A, Section A.11, Accessory # 17 (Cutting Edge):
Is there a link between this accessory (Cutting Edge) and the specification # 3 (Bucket)?

Answer 3: No; however, we have to change the accessory description # 17 as follows:

- delete: ~~Bolt on cutting Edge 88 inches~~ with quick coupler (female).
 - insert: Bulldozer-type blade with quick coupler (female), between 84 (minimum) and 88 (maximum) inch wide.
