CBSA ASSESSMENT AND REVENUE MANAGEMENT (CARM) SOLUTION – UPDATE

This is not a solicitation document. This is an update regarding the expected issuance of the Invitation to Qualify (ITQ) for the CARM Solution.

1. Executive Summary

The Government of Canada is intending to procure the services of a contractor to design, build and deploy the CARM solution across people, process and technology with quality, cost and schedule certainty.

The procurement process for this requirement was launched on May 7, 2015 with a Letter of Interest (LOI/A), that closed on August 5, 2015. The purpose of the LOI was to initiate engagement with industry, to seek interest from potential suppliers to participate in information sessions such as Industry Day and One-on-One meetings and to confirm that industry is interested in investing for this procurement.

On May 28, 2015 an Industry Day occurred and was attended by 29 firms/associations, as well as government representatives, for a total of 113 attendees, including those who joined in via WebEx/teleconference. The Industry Day served to provide an overview of the CARM project including the proposed approach, scope, and high-level capabilities to be delivered, a review of the key business issues and questions for which Canada is seeking industry feedback and an explanation of the proposed procurement approach.

The Industry Day was followed by the issuance of an amendment to the Letter of Interest (LOI) on June 3, 2015. The purpose of this amendment was mainly to provide instructions on the one-on-one meetings and how they will be conducted. Thirteen written responses to the LOI provided detailed feedback on many aspects of the procurement, and a further thirteen one-on-one meetings with industry allowed for further engagement with global leaders.

The LOI provided the opportunity for Canada to consider adjustments to the future stages of the project and the associated procurement process.

2. Update

Please note that the Invitation to Qualify (ITQ) has not yet been issued. It was mentioned at the Industry Day that the ITQ posting was targeting August 2015 as a planned release date. Canada is still gathering key information to refine the CARM requirements. Canada's intention to publish the ITQ will be communicated at a later date.

In addition, please note that all questions received during the one-on-one meetings and their related answers will be provided through an amendment to this LOI.

3. Enquiries

The Government of Canada procures goods and services on behalf of departments and agencies using Buy and Sell, the Government Electronics Tendering Service. Suppliers are encouraged to continue to monitor the web site at www.buyandsell.gc.ca for further updates.

All industry enquiries and other communications related to the procurement process should be directed exclusively to the Contracting Authority.

This notice is a general information update and responding to this notice is not a prerequisite to participating in any future solicitation(s) in this regard.

Additional updates prior and after the release of the ITQ will be provided as amendments to this RFI notice, as needed.
