Q1. Can you please provide additional information regarding the type of steel required. You have requested steel A-513, but there are SEVERAL types of steel. Please see attached document for reference.

A1. We asked for a HREW which makes this A513 Type 1.

Q2. Could you please provide details on the work you will do with the steel as there are many choices in on A-513.

A2. Scratches are also to be at minimal as this is tubing for furniture and deep scratches are not acceptable.

Q3. Could you please provide in percentage (%) the acceptable rust and scratch.

A3. Very minimal surface rust is allowed. No rust is preferred as this adds time for cleaning. Absolutely no scale rust allowed. Scratches are also to be at minimal as this is tubing for furniture and deep scratches are not acceptable.

Q4. Do the tubes need to be packed individually?

A4. The tubing only needs to be plastic wrapped as a bundle not individual.
