APPENDIX 1- TECHNICAL INFORMATION QUESTIONNAIRE - 53' VAN BODY, 35 TON TRI-AXLE TRAILER

PART 1 - GENERAL INFORMATION

1.1 Requirement

Canada is seeking proposals to procure:

1.1.1 Qty: 3, 53' Van Body, 35 Ton Tri-Axle Trailer, Configuration A and Qty: 1, 53' Van Body, 35 Ton Tri-Axle Trailer, Configuration B and related items as described in Annex "A" - Pricing and in accordance with Annex "B"- Purchase Description – 53' Van Body, 35 Ton Tri-Axle Trailer dated 2015-07-16.

1.1.2 Irrevocable options identified in Annex "A"- Pricing.

1.1.2.1 The options may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

1.1.2.2 The options may be exercised in whole or in part and on more than one occasion at the sole discretion of Canada, up to the maximum quantity identified in Annex "A"- Pricing.

1.1.2.3 The options may be exercised within twelve (12) months after contract award.

1.2. Debriefings

Bidders may request a debriefing on the results of the bid solicitation. Bidders should make the request to the Contracting Authority within 15 working days of receipt of notification that their bid was unsuccessful. The debriefing may be provided in writing, by telephone or in person.

1.3. Trade Agreements

The requirement is subject to the provisions of the World Trade Organization Agreement on Government Procurement (WTO-AGP), the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT).

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the Standard Acquisition Clauses and Conditions *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) Manual issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract. The 2003 (2015-07-03) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of 2003, Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

Delete: sixty (60) days

Insert: ninety (90) days

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a "proprietary" nature must be clearly marked "proprietary" at each relevant item. Items identified as proprietary will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in *Ontario*.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

2.5 Environmental Considerations

Canada is committed to greening its supply chain. In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to acquire products and services that have a lower impact on the environment than those traditionally acquired. Environmental performance considerations include, among other things: the reduction of greenhouse gas emissions and air contaminants; improved energy and water efficiency; reduced waste and support reuse and recycling; the use of renewable resources; reduced hazardous waste; and reduced toxic and hazardous substances. In accordance with the Policy on Green Procurement, for this solicitation:

- Suppliers are requested to provide all correspondence including (but not limited to) documents, reports and invoices in electronic format unless otherwise specified by the Contracting Authority or Project Authority, thereby reducing printed material.
- Suppliers should recycle (shred) unneeded copies of non-classified/secure documents (taking into consideration the Security Requirements).
- Product components used in performing the services should be recyclable and/or reusable, whenever possible.

2.6 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications, Statement of Work or Purchase Description contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least seven (7) days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that bidders provide their bid in separately bound sections as follows:

Section I: Technical Bid (2 hard copies);

Section II: Financial Bid (1 hard copy);

Section III: Certifications (2 hard copies);

Section IV: Additional Information (2 hard copies)

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation;

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process Policy on Green Procurement

(<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, bidders should:

- 1) use paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Bidders should complete and submit with their bid the following:

Appendix "1" - Technical Information Questionnaire - 53' Van Body, 35 Ton Tri-Axle Trailer.

1. Substitute and Alternatives

Bidders may propose substitutes and alternatives where "**shall**^(E)" is indicated in the technical requirement description (Purchase Description/Statement of Requirement/Statement of Work). Offerors / suppliers are encouraged to offer or suggest green solutions whenever possible.

1.1 Substitutes and alternatives that are equivalent in form, fit, function and performance will be considered for acceptance by the Technical Authority where the Bidder:

- (a) Clearly identifies a substitute and/or an alternative;

- (b) Designates the brand name, model and/or part number of the substitute and/or of the product, where applicable;
- (c) States that the substitute product is fully interchangeable with the item specified in the technical requirement description;
- (d) Provides complete specifications and brochures, where applicable;
- (e) Provides compliance statements that include technical details showing the substitute and/or the alternative meet all technical requirements specified in the technical requirement description; and
- (f) Clearly identifies those areas in the technical requirement description and in the brochures that support the substitute and/or the alternative compliance with the technical requirements.

1.2 Substitutes and alternatives offered as equivalent in form, fit, function and performance will not be considered for acceptance by the Technical Authority if:



- (a) The bid fails to provide all of the information requested to allow the Technical Authority to fully evaluate the evaluate the equivalency; or
- (b) The substitute and/or the alternative fail to meet or fail to exceed the technical requirements specified in the technical requirement description.

Section II: Financial Bid

Bidders must submit their bid in accordance with the Basis of Payment specified in Part 6 and Annex A - Pricing. The total amount of applicable taxes must be shown separately.

1. SACC Manual Clauses

1.1 Exchange Rate Fluctuation Risk Mitigation

1. The Bidder may request Canada to assume the risks and benefits of exchange rate fluctuations. If the Bidder claims for an exchange rate adjustment, this request must be clearly indicated in the bid at time of bidding. The Bidder must submit form PWGSC-TPSGC 450 , Claim for Exchange Rate Adjustments with its bid, indicating the Foreign Currency Component (FCC) in Canadian dollars for each line item for which an exchange rate adjustment is required.
2. The FCC is defined as the portion of the price or rate that will be directly affected by exchange rate fluctuations. The FCC should include all related taxes, duties and other costs paid by the Bidder and which are to be included in the adjustment amount.
3. The total price paid by Canada on each invoice will be adjusted at the time of payment, based on the FCC and the exchange rate fluctuation provision in the contract. The exchange rate adjustment will only be applied where the exchange rate fluctuation is greater than 2% (increase or decrease).
4. At time of bidding, the Bidder must complete columns (1) to (4) on form PWGSC-TPSGC 450 , for each line item where they want to invoke the exchange rate fluctuation provision. Where bids are evaluated in Canadian dollars, the dollar values provided in column (3) should also be in Canadian dollars, so that the adjustment amount is in the same currency as the payment.

5. Alternate rates or calculations proposed by the Bidder will not be accepted for the purposes of this exchange rate fluctuation provision.

Section III: Certifications

Bidders must submit the certifications required under Part 5 - Certifications.

Section IV Additional Information

Canada requests that bidders submit the following information:

1.2 Optional Quantity

If an option is exercised, the best delivery that can be offered is as follows:

Item 005 – Up to Qty: 3, 53' Van Body, 35 Ton Tri-Axle Trailer, Configuration A and related items will be delivered within _____ calendar days after an option is exercised.

Item 006 – Up to Qty: 1, 53' Van Body, 35 Ton Tri-Axle Trailer, Configuration B and related items will be delivered within _____ calendar days after an option is exercised.

2. Manufacturer's Standard Warranty Period

Canada requests that the Bidder provide details of the manufacturer's standard warranty period for the vehicle/equipment and its component that exceeds the minimum warranty period of twelve (12) months.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1. Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Mandatory Technical Evaluation Criteria

4.1.1.1 Mandatory Proof of Compliance

Bidders must submit, with their bid, all proof of compliance required in the Annex B - Purchase Description and the Appendix 1 - Technical Information Questionnaire.

4.1.1.2 Substitutes and/or Alternatives

Bidders proposing substitutes and/or alternatives must provide all the information as detailed in Part 3 - Substitutes and Alternatives to be considered for evaluation.

4.1.2 Mandatory Financial Evaluation Criteria

4.1.2.1 Bidders must provide, with their bid, the financial information requested in the bid solicitation and at Annex A - Pricing for items 001, 002, 003, 004, 005 & 006.

4.1.2.2 The prices of the bid Bids must be in Canadian dollars, DDP Delivered Duty Paid at destination, Incoterms 2000, for the firm quantity for items 001, 002, 003, 004 and FCA Free Carrier at Contractor's Canadian facility, Incoterms 2000 for optional quantities items 005 and 006. Canadian Custom Duties and Excise Taxes included where applicable, and Applicable Taxes are extra.

4.1.2.3 Aggregate Evaluated Price

Bids will be evaluated on an aggregate price basis for the firm quantity, optional quantity and familiarization instruction/training (option) as follows:

- a) the firm unit price for the firm quantity, the optional quantity and familiarization instruction/training (option) will be multiplied by their identified estimated quantities; and
- b) the sum of all results will determine the aggregate evaluated price.

4.2. Basis of Selection

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical and financial evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated aggregate price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

5.1.1 Declaration of Convicted Offences

As applicable, pursuant to subsection Declaration of Convicted Offences of section 01 of the Standard Instructions, the Bidder must provide with its bid, a completed Declaration Form, to be given further consideration in the procurement process.

5.2 Certifications Precedent to Contract Award and Additional Information

The certifications and additional information listed below should be submitted with the bid, but may be submitted afterwards. If any of these required certifications or additional information is not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to provide the certifications or the additional information listed below within the time frame provided will render the bid non-responsive.

5.2.1 Integrity Provisions – List of Names

Bidders who are incorporated, including those bidding as a joint venture, must provide a complete list of names of all individuals who are currently directors of the Bidder.

Bidders bidding as sole proprietorship, as well as those bidding as a joint venture, must provide the name of the owner(s).

Bidders bidding as societies, firms or partnerships do not need to provide lists of names.

5.2.2 Federal Contractors Program for Employment Equity - Bid Certification

PART 6 - RESULTING CONTRACT CLAUSES

6.1. Requirement

6.1.1 The Contractor must deliver Qty: 3, 53' Van Body, 35 Ton Tri-axle Trailer, Configuration A and Qty: 1, 53' Van Body, 35 Ton Tri-axle Trailer, Configuration B and related items as described in Annex "A" - Pricing and in accordance with Annex "B" - Purchase Description – 53' Van Body, 35 Ton Tri-Axle Trailer dated 2015-07-16.

6.1.2 The Contractor grants to Canada irrevocable options identified in Annex "A"- Pricing.

6.1.2.1 The options may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

6.1.2.2 The options may be exercised in whole or in part and on more than one occasion at the sole discretion of Canada, up to the maximum quantity identified in Annex "A"- Pricing.

6.1.2.3 The options may be exercised within Twelve (12) months after contract award.

6.1.3 Optional Extended Warranty Period (if applicable)

6.11 Inspection and Acceptance

The Technical Authority is the Inspection Authority. All reports, deliverable items, documents, goods and all services rendered under the Contract are subject to inspection by the Inspection Authority or representative. Should any report, document, good or service not be in accordance with the requirements of the Statement of Work and to the satisfaction of the Inspection Authority, as submitted, the Inspection Authority will have the right to reject it or require its correction at the sole expense of the Contractor before recommending payment.

6.12 Preparation for Delivery

The vehicle / equipment must be serviced, adjusted and delivered in condition for immediate use. The interior and exterior must be cleaned before leaving the factory and being released to inspection authority or consignee personnel at the final delivery location.

The fuel tanks must be at least half full prior to release of the vehicle(s) to inspection authority or consignee.

All vehicles delivered to the consignee are to be delivered between the hours of 8:00 am and 4:00 pm Monday through Friday, except Federal holidays. PURCHASE DESCRIPTION FOR 53' VAN BODY, 35 TON TRI-AXLE TRAILER

1. SCOPE

1.1 **Scope.** This document covers the requirement for the following:

Configuration A: 53 foot, semi-trailer, dry van body, tridem axle; and

Configuration B: 53 foot, semi-trailer, refrigerating van body, tridem axle.

1.2 **Instructions.** The following instructions apply to this Purchase Description:

- a) Requirements, which are identified by the word “**shall**”, are mandatory. Deviations will not be permitted.
- b) Requirements identified by “**shall^(E)**” are mandatory. The Technical Authority will consider equivalents for acceptance as a Technical Authority Approved Equivalent.
- c) Requirements identified with a “will” define actions to be performed by the Crown and require no action/obligation on the Contractor’s part.
- d) Where “**shall**”, **shall^(E)**, or “will” are not used, the information provided is for guidance only.
- e) In this document “provided” **shall** mean, “provided and installed”.
- f) Where a standard is specified and the Bidder has offered an ***Equivalent***, that ***Equivalent*** standard **shall** be provided.
- g) Where a technical certification is referred to in this Purchase Description, a copy of the certification or an acceptable proof of compliance shall be provided for the vehicle when requested by the Technical Authority up until the date of the expiration of the warranty period;

h) While the SI system shall be used as the primary system of measurement to define requirements in this Purchase Description, both the SI system and the Standard system of measurements are usually indicated. Conversions from one system of measurement to the other may not be exact; and

i) Dimensions stated as nominal **shall** be treated as approximate dimensions. Nominal dimensions reflect a method by which materials or products are generally identified for sale commercially, but which differ from the actual dimensions.

1.3 Definitions. The following definitions **shall** be applied to the interpretation of this Purchase Description:

(a) “Technical Authority” (TA) is the government official responsible for technical management of this requirement. The Technical Authority is the Director Support Vehicles Program Management.

(b) “Technical Authority Approved Equivalent” means a standard, means, or component type, which has been evaluated by the Technical Authority and determined to meet the specified requirements for form, fit, function, and performance.

3. REQUIREMENTS

3.1 Standard Design

(a) The design **shall** be the manufacturer's latest model having demonstrated industry acceptability by having been manufactured and sold commercially for at least two (2) years, or **shall** be manufactured by a company that has at least five (5) years of experience in design and manufacturing of a comparable type of equipment of equivalent or greater complexity.

(b) The design **shall** have engineering certification available, upon demand, for this application from the original manufacturers of major equipment systems and assemblies.

(c) The design **shall** conform to all applicable laws, regulations and industrial standards governing manufacture, safety, noise levels and pollution in effect in Canada at the time of manufacture.

(d) The design **shall** have system and component capacities not greater than their published ratings (i.e. product or component brochures).

3.2 Safety Standards

(a) The semi-trailer **shall** meet the provisions of the Canada Motor Vehicle Safety Act in effect on the date of manufacture of the system.

(b) Where required for operator safety, the semi-trailer safety features such as warning and instruction plates, non-slip walking surfaces and heat shields **shall** be provided.

3.3 Operating Conditions

(a) The system **shall** operate safely and efficiently as follows without degradation in performance, reliability and maintainability.

(b) The payload of the semi-trailer **shall** carry a payload of at least 31,500 kg uniformly distributed.

(c) The semi-trailer **shall** be able to operate on paved roads, gravel/dirt roads with severe washboard and pot holes.

(d) The semi-trailer **shall** operate in a temperature range of -40°C to 37°C.

(e) With the stated payload the semi-trailer **shall** operate under all operating conditions.

3.4 Semi-Trailer Components

3.4.1 Dimensions

(a) The system **shall** have a width of 2590 mm;

(b) The kingpin installed on the system **shall** have an operating height of 1,219 mm;

(c) Interior body **shall** have a maximum height of 2,616mm;

(d) The overall height **shall** be 4.15 m;

(e) Kingpin setback **shall** have a distance of 914 mm; and

(f) 51-mm kingpin **shall** be provided.

3.4.2 Brakes. The brake system shall be equipped as follows:

- (a) The semi-trailer shall be equipped with an anti-lock air disc brake system.
- (b) The semi-trailer shall be equipped with remote cable operated drain valves on the air reservoir tanks.
- (c) The semi-trailer shall be equipped with colour coded glad hand couplers for interconnection between semi-trailer and tractor.
- (d) Dummy glad hand couplers including a safety chain/cable for each glad hand shall be provided to prevent dirt and moisture in the main lines when they are not in use.

3.4.3 Axles. The semi-trailer, with axles of appropriate capacity to carry maximum payload specified in this document, shall be provided.

3.4.4 Suspension

- (a) The semi-trailer shall have an air suspension.
- (b) The suspension shall have a manual suspension air dump valve;
- (c) An air gauge to assist the operator in adjusting the ride height shall be provided;
- (d) Suspension travel limiters shall be provided.
- (e) The travel limiters shall be cables or chains fastened to the suspension beam or axle and the under frame at a length approximately equal to or less than the shock absorber extended stroke. The use of shock absorbers as travel limiters is not acceptable.

3.4.5 Tires and Wheels.

- (a) The tires shall have size and ply ratings which comply with CMVSS.
- (b) The tires shall have load ratings capable of handling max load capacity of the semi-trailer.
- (c) The system shall have tire pressures marked near each of the tire locations.
- (d) Non-polished aluminum rims shall be provided.
- (e) A hubodometer reading in kilometers shall be provided.
- (f) Each wheel station shall be provided with loose wheel nut indicators.

3.4.6 Landing Gear.

- a) An interconnected two-legged landing gear shall be provided.
- b) The landing gear shall withstand the weight of the fully loaded semi-trailer when not in use.

3.4.7 Electrical System

- (a) The electrical system shall be a 12-volt negative ground electrical system.

- (b) Lights and reflectors shall be recessed or otherwise protected from damage.
- (c) The electrical system shall have a standard 7-pin semi-trailer receptacle.
- (d) All components shall be accessible for servicing.
- (e) **Protected Wiring and Workmanship**
 - i. The wiring shall be protected by design and positioning to prevent damage and contact with spilled hydrocarbon fuels.
 - ii. This shall meet the minimum requirements of NFPA 407 (paragraph referring to **Vehicle Lighting and Electrical Equipment**).
 - iii. This shall include as a minimum electrical wiring used for the connection to the tractor vehicle designed for heavy-duty use, with positive engaging connectors, which are mounted securely to the semi-trailer.
 - iv. All wiring shall be protected by grommets when passing through metal.
 - v. The harnesses shall be sealed harnesses and all connections treated with dielectric grease.

3.4.8 Lighting

- (a) The lighting system shall conform to CMVSS 108 requirements.
- (b) All lighting shall be LED.
- (c) Mid-ship combination turn and clearance lights shall be provided on left and right sides.
- (d) Five LED clearance lights on rear at top of the door shall be provided. One at each corner and a cluster of three in the middle.
- (e) Two stop, tail and turn signal light assemblies shall be provided on each lower rear corner.
- (f) Interior lighting shall be provided for a working environment.

3.4.9 Floor

- a) The floor shall have the strength for loading/unloading by forklift with a 4,540 kg GVW and 3,630 kg single axle load.
- b) The floor shall be kiln dried hardwood floor with tongue and groove or ship lapped construction.
- c) Two rows, full length on each side of floor with an integrated securement track with minimum 12 multi-position cargo hands shall be provided.
- d) The threshold plate, constructed of 12 inch checker plated steel shall be routed into the floor and welded across the rear.

3.4.10 Doors

- a) Two (2) rear full height, full-width barn type doors shall be provided.

- b) Compression type door hardware on each door, with provision for locking with a padlock, shall be provided.
- c) Molded rubber door seals shall be provided.
- d) Devices to secure the doors in the full open position shall be provided.
- e) A minimum of four hinges per door shall be provided.
- f) One side door located on the curb side, just rear of the landing gear, shall be provided
- g) The side door opening shall be provided with a dimension of 1,854 mm high by 914 mm wide.
- h) **Config B only**: Two (2) insulated rear full height, full-width barn type doors shall be provided.

3.4.11 Miscellaneous Equipment

- (a) All systems and components shall be located and/or protected from road hazards such as water, mud and gravel.
- (b) Two rear towing points positioned with strength to permit recovery shall be provided.
- (c) Black mud flaps rear of the rear axles shall be provided. The mud flaps shall be without logos or markings. Aerodynamic mud flaps are preferred.
- (d) Strips of reflective tape shall be applied in accordance with Transport Canada regulations.
- (e) An illuminated licence plate holder shall be provided at the rear of the semi-trailer.
- (f) Aerodynamic side skirts shall be provided on both sides of the semi-trailer.
- (g) Heavy duty, rubber dock bumpers, 102 mm deep shall be located at the rear corners.
- (h) Two logistic tracks shall be provided. The tracks shall run the length of both sidewalls. They shall be recessed and mounted at heights of 762 mm and 1,524 mm from the floor. These tracks shall be equipped with a minimum of 10 tie-down straps.
- (i) Two heavy-duty telescopic poles shall be provided.
- (j) A regulation size underride (ICC) bumper shall be provided.
- (k) Access steps with grab handles for ease of access into the trailer through all doors shall be provided.
- (l) A document holder located at the front of the semi-trailer shall be provided.

3.5 Walls

- a) **Config A**: Interior walls shall be lined with a 12 gauge galvanized protective

barrier to a height of at least 660 mm from the floor.

b) **Config B:**

- i. The side walls with minimum 51 mm insulation **shall** be provided.
- ii. The interior walls covered with a thermal guard **shall** be provided.
- iii. The insulated interior walls **shall** be lined with a 12 gauge galvanized protective barrier to a height of at least 660 mm from the floor.

3.6 Roof

a) **Config A:**

- i) A one piece Kemlite translucent fiberglass riveted around the perimeter to recessed roof rails and bonded to pre-cambered aluminium or steel roof bows **shall** be provided.
- ii) Two evenly spaced full-length ceiling mounted rub strips **shall** be provided. The rub strips **shall**^(e) be designed to incorporate the interior lighting and act as a protection to prevent loads from catching on the cross members.

b) **Config B:** An insulated ceiling of greater thickness than the walls for config B **shall** be provided.

3.7 Refrigerating Unit (Config B)

- a) The semi-trailer **shall**^(e) be provided with a fuel powered (diesel), self-contained, thermostat controlled refrigerating unit.
- b) The refrigerating unit **shall** run continuously for at least 24 hours before having to be refilled with fuel.
- c) The unit **shall** be located at the front of the semi-trailer.
- d) A thermostat controlled refrigerated unit **shall** be provided to maintain the cargo at a selected temperature within the range of -29° Celsius to +10° Celsius.

3.8 Speed. The semi-trailer **shall** be able to be towed at a speed of 105 km/h at rated maximum payload.

3.9 Paint and Corrosion Protection.

- (a) **Paint.** The semi-trailer **shall** be painted in accordance with the manufacturer's best production procedures using standard commercial practices and materials, rendering a durable finish of the required film thickness and a smooth appearance free from runs, sag and orange peel.
 - i. The chassis items **shall** be painted black.
 - ii. Chromed, polished and mill finished surfaces **shall** not be painted.
 - iii. All exposed exterior surfaces normally painted for the commercial trade **shall** be painted white.

iv. All additional lettering and symbols on the outside of the semi-trailer shall be flat black using paint compatible with the topcoat selected. The colour shall be flat black 37030 in accordance with FED STD 595.

(b) **Corrosion Protection System**

- i. Dissimilar metals shall be protected against galvanic corrosion.
- ii. A rust prevention coating shall be applied to the semi-trailer underbody. The product applied shall^(E) be Tectyl, Krown Rust, or Rust Check.

3.10 Miscellaneous

3.10.1 Identification Plate. The following information shall be provided as a minimum, permanently marked and in a conspicuous and protected location:

- (a) Manufacturer, model, model year and serial number shall be provided;
- (b) GAWR and GVWR ratings shall be provided; and
- (c) The maximum payload capacity located near or on the identification plate shall be provided.

3.10.2 Warning and Instruction Plates. The following shall be provided:

- (a) All plates within easy view of the user and in accordance with standard commercial practice.
- (b) International symbols and/or bilingual markings.
- (c) Instructions for engine starting and any other special procedures to be followed.

3.10.3 Lubricants and Fluids. The semi-trailer shall be serviced with standard lubricants and fluids compatible with the delivery location and season.

4 DELIVERABLE INFORMATION

(a) Equipment Manuals

- i. The Contractor shall provide an electronic copy on CD/DVD of the Operator's manual, parts manual and maintenance manual to the Technical Authority.

- ii. Parts Manuals. The Parts Manuals shall be in English (French translation is desirable).
- iii. Maintenance (Shop Repair) Manuals. The Maintenance (Shop Repair) Manual shall be in English (French translation is desirable).
