DELETE: **4.2 Basis of Selection** in its entirety

INSERT: **4.2 Basis of Selection**

A bid must comply with all requirements of the bid solicitation and meet all mandatory technical and financial evaluation criteria to be declared responsive.

The responsive bid with the lowest evaluated aggregate price will be recommended for award of a contract (1 contract only). Evaluation will be established using the firm quantities for the all items, and 100% of the option quantities and 100% of the "as and when requested" quantity.

In Amendment 002 of the solicitation change the answer at Question 4:

Q4. Is there a fly on the required model of men's underwear?

DELETE: A4. Yes. See Annex B, paragraph 3.4.2.

INSERT: **A4. A fly is NOT required.**

QUESTION /ANSWER

Q11. Could you tell me if the two samples per size range from small to 2XL? And is this in men's and women's styles?

A11. According to Annex B paragraph 3.8, "The contractor must propose the sizes to fit the Canadian Armed Forces (CAF) population." According to Annex C paragraph 2.2, "the Bidder must provide one (1) garment sample of each size proposed for each type of underwear, Type I-Mens's and Type II-Women's."

All other terms and conditions remain the same.
