Q4. How many calls are there on average in each month?

A4. Refer to question 2 in solicitation amendment 001 for an indication of the number of calls.

Q5. For these calls, what kinds of questions to they usually ask?

A5. Calls are questions about how to manage acute care presentations includng whether to medevac or whether it is safe to hold the patient treating and monitoring for improvement.

Q6. How long does each call take on average?

A6. Calls are usually a few minutes in length, usually not more than 10 minutes.

Q7. Where do the calls usually come from?

A7. As identified in the Statement of Work in Annex "A", calls come from naval vessels anywhere in the world or in other remote locations.
