The purpose of this amendment is to :

- 1) modify the bid solicitation as detailed in Section A; and
- 2) Provide answer to questions from suppliers as detailed in Section B.

Section A - Modification to the bid solicitation

At the Statement of Work section 4.2.8 - Orientation and Wellness Sessions

Delete: "Wellness Session: one-hour educational session or lunch and learn related to issues of health and wellness of employees and managers (for example, sessions on grief, parenting, or stress management). The sessions must be delivered by a Professional Counsellor that meets the qualifications detailed in section 7.3."

Insert: "Wellness Session: one-hour educational session or lunch and learn related to issues of health and wellness of employees and managers (for example, sessions on grief, parenting, or stress management). The sessions must be delivered by a Professional Counsellor that meets the qualifications detailed in section 7.3 or a Facilitator that meets the qualifications detailed in section 7.7."

At the Statement of Work section 7. RESOURCE QUALIFICATIONS

Insert:

7.7 Facilitators

The Facilitators must have Bachelor's or Master's Degree in Social Work, Psychology or in another discipline related to counselling with a minimum 3 years' experience providing clinical counselling services or delivering wellness sessions.

The education must be from a recognized Canadian university or the equivalent as established by a recognized Canadian academic credentials assessment service, if obtained outside Canada. Section B - Questions and Answers

First set of Q&A

- Q1. At Attachment 1 to Part 4, Criteria MT4 states: *The bidder must provide at a minimum the following information: 4) A copy of an invoice (monthly invoice).* What specific information is required to appear on the sample invoices? Can the supplied sample invoice be any type of invoice (i.e. monthly invoice or a reconciliation invoice, typically emitted at year-end)?
- A1. Canada is not looking for a "sample invoice" but an existing monthly invoice against a previous or current EAP Services contracts sent to a similar sized and unionized external client organization(s).

- Q2. At Attachment 1 to Part 4, Criteria MT5. What specific information must be provided by the bidder to demonstrate compliance to MT5? Can we choose any location within the 8 regions to demonstrate compliance?
- A2. It is the Bidder's responsibility to demonstrate compliance by providing proof, descriptions, statements, examples, log-sheets, reports, tables, screen shots etc. Bidders must choose locations within the 8 regions that meet the criteria and constraints.
- Q3. At Attachment 1 to Part 4, Criteria MT6: For how many client organizations must bidders present the required information? Can bidders present an average of calls per month, over one year or should the total since 2012 be submitted? Should bidders submit only the number of crisis intervention calls, or all calls made?
- A3. The Bidder must have at least one client organization that meet the criterion. As stated in the criterion, the Bidder must demonstrate that it offered the services for at least two consecutive years after October 1st, 2012. In addition to the information requested, Bidders must provide the number of calls made for the Crisis Intervention counselling per month.
- Q4. At Attachment 1 to Part 4, Criteria MT7: To demonstrate compliance, are bidders required to provide the above information for 50 in-person wellness sessions that have been delivered or the title and number of sessions delivered by location? Are bidders required to provide information for a total of 50 sessions across four of the six areas, or 50 sessions in each of the four areas covered for a total of 200 sessions for example?
- A4. As stated in the criterion, the Bidder must provide the information for the 50 in-person sessions in at least cover four of the six areas. The minimum number of sessions is 50 in total.
- Q5. At Attachment 1 to Part 4, MT9: What specific information must be provided by the bidder to demonstrate compliance to MT9? Should bidders list all 20 incidents? Can multiple incidents with the same client be considered for compliance?
- A5. It is the Bidder's responsibility to demonstrate compliance by providing proof, descriptions, statements, examples, log-sheets, reports, tables, name of the organization, dates, location, etc. The Bidder must demonstrate that it has provided 20 onsite CISM debriefing sessions and not a detailed description of the incidents. Canada is looking for "onsite CISM debriefing sessions" which was offered to the same external organization or not.
- Q6. At page 31 of 54, section 4.2.8 states: *Wellness Session: one-hour educational session or lunch and learn related to issues of health and wellness of employees and managers (for example, sessions on grief, parenting, or stress management). The sessions must be delivered by a Professional Counsellor that meet the qualifications detailed in section 7.3.*
- Is Canada open to these sessions not being delivered by professional counselors and change the criteria to a Bachelor's Degree + 10 years of related experience or Master's Degree + 5 years of related experience?
- A6. Canada agrees to change the requirement. See modification in Section A.
- Q7. At page 33 of 54 states: *The Contractor must provide all the facilities for face-to-face counselling sessions and face-to-face advisory services within 100 km of any and all CBSA work locations identified in Appendix 1.* For compliance, do bidders need to provide all office locations within 100 KM of each CBSA location as described in Appendix 1?
