This solicitation amendment 001 is raised to provide this question and answer set 1.

Question and Answer Set 1

Question 1.

I had a question concerning the specification 4.1 at Annex A. It says " The HERO class vessels operate in corrosive, saltwater environments. The unit's housing shall be constructed using 316L Stainless Steel to protect from corrosion". Can you be more specific about what is meant by the "housing". Do you mean the reactor chamber? Or is it a compartment in which the UV reactor shall be installed? Also, there is information concerning the UV reactor but not much about the controller. Does the controller need to have a certain corrosion resistance and be stored in, let's say, a nema 4X box? Some more information on that matter would help too.

Answer 1.

Specification 4.1 at Annex A is referring to the reaction chamber inside where the lights and water interact. CCG is requesting 316L stainless because it is a better material for corrosion resistance than the standard 304 stainless.

The control box should have an enclosure around it but CCG is not defining to which standard the enclosure should meet. An indoor land based enclosure will meet CCG's needs.
