**SOLICITATION AMENDMENT 003 IS RAISED TO RESPOND TO QUESTIONS,  
AS FOLLOWS:**

**Q8. We needed some clarity on Q2 from Amendment No. 1 - is the 9 calls or less for a one-year period, or 9 calls for a 4-year period?**

*A8. 9 calls or less per year.*

**Q9. Will the contracted physician be treating/advising Canadians or non-Canadian patients as well?**

*A9. Canadian patients only unless otherwise authorized by the Minister of National Defence in advance.*

**Q10. Is it usually one patient to be taken care of per call?**

*A10. Usually.*

**Q11. Does the contracted physician have the liability for the patient or is he/she just providing advice?**

*A11. Please refer to Medical Malpractice Liability Insurance requirement on page 18 of solicitation document.*

**Q12. Why did the relationship with the current contractor end? Will they be rebidding?**

*A12. Contract was for a defined term. Whether they will be bidding on this contract is unknown.*
