The following Addendum to the tender is effective immediately. This addendum shall form part of the contract documents.

All other terms and conditions remain the same.

Addendum No. 6

QUESTIONS AND ANSWERS

- Q1:** We will need to know if the wall of Building-80 that the addition is attached to is a fire-rated wall? Also, we need to know if the existing exterior door is a dedicated fire exit.
- R1:** The existing exterior wall on Grid 1, to which the addition is to be attached, is not fire-rated. Please note, no walls in the 'new' addition are required to be fire-rated or have a fire resistance rating. The existing double doors on Grid 1 is currently a required exit but has no required fire rating. The existing exit devices on these doors have no exterior trim so they function as an exit only with no "entry" capability since there is no way to retract the latch on the exterior side. When these door panels & associated exit devices are relocated to the new frame on Grid 1 they likewise will only function as the required exit and will continue to have no "entry" capability. While, the new doors to be installed on Grid 1, and their associated hardware, will allow egress through the doorway in either direction.
- Q2:** If yes, then the corridor through the addition would need to be rated as well. The travel distance would also need to be re-calculated.
- A2:** See responses for 1 above and 3 below.
- Q3:** Please provide information regarding Building-80 for fire exists and travel distances.
- R3:** Although, the new addition extends the original egress route at the North end of the building by approximately 12 meters, locations of exits will remain in compliance with NBCC-2010 requirements. NBCC-2010 Item 3.4.2.5(f) requires that travel distances to at least one exit do not exceed 30 m. With the addition, all floor areas are within 30 m of an exit.
- Q4:** Please provide sizes of the existing doors in Building 80 that are to be re-located. We need to know to allow the correct frame size in the new addition.

- A4:** This will be part of the Design process. Please note, drawings of Building 80 will be made available to the successful proponent.
- Q5:** Also, is G40 Galvanneal coating acceptable for the new doors and frames?
- R5:** Products and materials will be considered as part of the Design process.
- Q6:** Also, The tender form indicates a completion date of March 28, 2015 and the milestone dates on page 10 of the Design-Build Terms of Reference indicate Substantial Completion of February 20, 2016. Would a Substantial Completion date of March 28, 2015 be acceptable? Also, can some exterior activities be completed after the March 20th date, asphalt for example, that are weather dependent?
- A6:** Substantial completion is to be March 28, 2015. The Milestone dates (page 10 of 43) within the Terms will be adjusted upon award. Seasonal deficiencies may be required at the time of Substantial.
