- ***There is no financial proposal required with this offer. Financial proposals will be required when DFO has specific work requirements.***

- Annex G section 1.2 – It reads “To be responsive...utilizing **the rates** and personnel in their SA”.

- ***Please remove the reference to rates in this sentence.***

- Part 6 - Section **B** – 6.2.2 – Re “This process is outlined in “**Annex E**” – **Contracting Process / Statement of Work Format**.”

- ***It should read Annex G.***

- Part 6 – Section **C** – 6.2.1 – Basis of Payment – It reads “...the Contractor will be paid firm prices / lot prices, as specified in **Annex “B” – Basis of Payment of the individual requirements**”.

- ***Annex B in this instance, refers to the client’s individual requirements that they will be requesting pricing for.***

- Section 5.1.1 (Declaration of convicted offence) does this form need to be submitted with the offer?

- ***This form is only required if the bidder has been convicted of offenses.***
