This solicitation is hereby amended to:

**1. Provide the following questions and answers:****Q2. Is there a current Burglar/Intrusion Alarm existing at the locations?**

A2. At some sites, yes.

**Q3. Would there be a requirement for a Monitor, Mouse and Keyboard for the NDVRs?**

A3. Yes

**Q4. As some of the equipment requires training/support prior to installation is there going to be provisions made for this training?**

A4. Yes, at the installation phase.

**Q5. Why would the client not allow for the supplying company to perform the installation?**

A5. If supplier has local authorized technicians, they can install.

**Q6. Reference: 3. General Purpose Camera - Waiting/Corridor Areas**

**Can you please provide the name of a manufacturer that can provide a 6mp camera?**

A6. SeSys, Avigilon, Samsung, Aventura, eLine Technology, Vivotek, Hikvision, Mobotix, Bushnell, and others.

**Q7. Please advise if any or all of these alternative specifications (underlined) are acceptable:**

**6.1) 1. The proposed NDVR (Network Digital Video Recorder) must meet or exceed the following specifications:**

**f) Must support up to 6 Megapixel cameras alternate : Must support up to 5mp cameras.**

**j) 4 USB ports for external drives and devices alternate: 3 USB ports.**

**6.2) 2. Dome Camera - Reception Area**

**a) Must have 6MP image sensor alternate: 5mp image sensor**

**c) Must have 5 year warranty alternate : 3 year warranty**

A7. These are not acceptable.

**Q8. Reference: 4. Uninterruptable Power Supply (UPS)**

The proposed UPS must meet or exceed the following specifications:

- a) Simulated on-battery Sine wave 120Vac (repeat) output (Mandatory)
- b) 1000 VA (volt amps)/600W (watts) rating (Minimum)
- c) Buck/Boast Voltage regulation technology (Mandatory)
- d) 8 Outputs (Minimum)
- e) POE switch

Please explain what is meant by "e) POE switch". Typically a UPS will not have an integrated network switch. Perhaps this should be a separate Deliverable line item? If so please advise on switch specifications, (i.e. number of ports, POE, managed vs unmanaged etc.).

**Q9. As the equipment listed in the Request for Standing Offer appears to be of a very specific nature in its requirements, is there a specific manufacturer, model and/or part number you could reference as an example for these 5 items?**

A9. Vivotek or Mobotix for cameras, Milestone Husky DVR, Various suppliers for dual stage duress alarm system. Or equivalent.

**Q10. Please advise the size of the area that needs to be covered in square feet.**

A10. Varies by location/camera type - Range of 10 sq ft to 400 sq ft.

**Q11. Please confirm that the design should be for one floor.**

A11. Usually single floor, occasionally multiple floors.

**Q12. Reference: Annex "A", 5. Duress Alarm System**

- a) 5. C: "origin of alarm activation" Please confirm if the requirement is to know where the wireless panic/duress button is physically located when it has been pressed.

A12. a) Yes

b) If answer yes above, please advise if there will be particular zones or rooms where the location needs to be known, if so how many zones rooms; or, please confirm if the location of the panic/duress button when pressed needs to be known regardless of where it is (the latter being much more expensive)

A12. b) Yes, there will be zones or rooms - number will vary by site (maximum 5)

p) Standard racking for cabinets is 19", please confirm if the equipment is to be mounted in non-industry standard equipment racks.**

A13. p) Standard equipment racks are acceptable

**u) Please provide your definition of a small-form factor NVR. Can we provide a DVR unit with a fan?**

A13. u) Definition: a smaller computer/NDVR with a fan free chassis DVR with fan is not acceptable.

**Q14. Reference: Annex "A", 2. Dome Camera - Reception Area and 3. General Purpose Camera - Waiting/Corridor Areas**

**a. Both camera models have the same specifications. Is there a difference between the two?**

A14. a. Yes Dome camera has 90 degree coverage, GP cameras 180 degree.

**b. Can you please provide a manufacturer who's cameras meet you specifications?**

A14. b. Yes, Vivotek, SeSys, Mobotix

**c. Which component requires solid state?**

A14. c. Cameras, NDVR

**Q15. Reference: Annex "A", 4. Uninterruptable Power Supply (UPS)  
Please provide a manufacturer which includes a POE switch in UPS.**

A15. Not required, Part (e) to be removed.

**Q16. Reference: Annex "A", 5. Duress Alarm System  
Please provide a manufacturer who meets these specifications.**

A16. System is drawn from several manufacturers and is composed of: (1) Dual stage panic alarm notification lights, (2) Wall mounted control unit to identify location of alarm, (3) Wireless surface mount and portable panic alarms (5 of each) and a Mass Notification System for messaging to email, SMS text and push notifications.
