Q21. In reference to the Mass Notification System; could you please provide additional details of this requirement, as these are usually enterprise systems. Will the server & UPS for this system be supplied & hosted by VAC?

A21. No server/UPS. Lockdown button in Reception connects to panel which triggers relays for the lights and activates cell phone to call Alarm Company which sends broadcast text message to staff mobile phones.
