**Amendment002 of Solicitation 201602924 has been issued to respond to Questions and Answers – Part 1; and to provide information on substitute products proposed; and to provide Addendums 001, 002, 003, and 004 to the Specifications/Drawings.**

**1. QUESTIONS AND ANSWERS – PART 1:**

Q1. According to note # 1 of drawing S001 it mentions to refer to a soils report, however, upon review of the specifications it appears that the report is missing from the document. Would you please provide the soils report.

A1. *Please reference Addendum001 section 1.1 for Geotechnical Report.*

Q2. Upon review of the specifications there are two different copies of Section 09 65 16. Which are we to follow?

A2. *Please reference Addendum002 section 2.12*

Q3. According to detail 3/A100 we are to provide 3 – 15M at 500 mm vertically, however, the note points to a horizontal bar. Please clarify what is required for horizontal and vertical reinforcing.

A3. *Please reference Addendum001 section 1.4*

Q4. Regarding drawing A303. Please clarify where detail 12-B is to be installed. Unfortunately, upon review of the drawings we cannot seem to locate this detail.

A4. *Please reference Addendum001 section 1.5*

Q5. Regarding drawing A300, section B/300. Please confirm that detail 12/303 is only required along gridlines '11' and '12'.

A5. *Please reference Addendum001 section 1.6*

Q6. According to detail 3/A102 we are to provide a 765 mm x 765 mm access hatch, however, section 07 72 33 states to provide a 914 mm x 914 mm. What size of access hatch is required

Q7. Please provide construction details on the existing asphalt parking lot.

Q8. Regarding drawing A100. Can the construction area within the temporary fence be increased by 5 meters all around in order to provide us with a safer and larger working area?

Q9. Upon review of the site conditions today there appears to be substantially a lot more existing sidewalk to dispose of than noted on drawing A100. Please issue an existing site conditions drawing noting all of the required removals

Q10. Ref section 12 49 40 – Horizontal Louvre Blinds. Please advise if the client is expecting fabric roller shades rather than horizontal louvre blinds? Perhaps section 12 24 13 would be the right one?

Q11. The exterior wall construction above the windows on both floors we believe should have structural steel studs however none are specified. Reference Sections 2 & 3 on A302

- Q12. Regarding detail 12/A303. Are we required to remove and replace the existing siding and parapet assemblies? If so. Please confirm along which gridlines this is to occur.

- Q13. Please provide specification for new Fire Rated Overhead Door shown on Drawing A303 , A101 (grid C/9) ground floor  
A13. *Please reference Addendum002 section 2.3*
- Q14. According to Section 6 on drawing A302 it mentions to provide 100 mm of concrete c/w steel on the roof deck, however, upon review of the roof plan on drawing S002 and the sections noted on drawing S003 there is no mention to provide such an item. Is concrete and steel required on the roof deck? If so. Please provide concrete reinforcing details

- Q15. Washroom Accessories 10 28 10; Please provide specification for Coat Hook shown in washrooms;  
A15. *Please reference Addendum002 section 2.5*
- Q16. Advise location of Towel Bar specified and not shown on drawings;  
A16. *Please reference Addendum002 section 2.6*
- Q17. Are Mirrors to be by section 10 28 10 or 08 80 50 as the drawings indicate frameless?  
A17. *Please reference Addendum002 section 2.7*
- Q18. Please provide the designation for the fixtures as there is nothing indicated on the layout drawings to reference to the fixture schedule.  
A18. *Please reference Addendum002 section 2.8*
- Q19. Please provide the spec and size for the OH fire shutter.

- Q20. Please provide the location of the existing fire alarm panel in the front entrance of the existing building, there is no true indication of the location of the front entrance.

- Q21. Is the final grading plan to be issued after award?

- Q22. May I have a copy of the Site Visit sign-in sheet?

- Q23. *Would you please provide a specification on the fire shutter noted on drawing A200. It appears to be missing from the document?*

- Q24. Door schedule has aluminum door size as 915 x 2135. Elevations show the doors full height (2755mm including frame). Also new code requires doors to be wider than 915mm. If doors are to be full height then a wider stile is highly recommended than specified (08 11 16 .2.2) as well as more butt hinges.

- Q25. There are two hardware lists for the aluminum doors. One on the door schedule A302 & one in section 08 11 16 .2.6. Please clarify hardware required.  
A25. *Please reference Addendum003 section 3.3*
- Q26. 08 44 13 .2.2.3 and .4 states that panels & flashings to be 8mm (5/16") thick. I do not believe this is possible. The industry standard for the interior (back pan) is galvanized steel as the pins that hold the insulation are welded to it. As for the exterior & the flashings is it possible they want .080 thick & not 8mm. Please clarify.

- Q27. There was no thermal insulation spec. provided for piping. For example, the domestic hot & cold water and the RWL –(storm piping) above grade were not specified to be insulated.

- Q28. According to the specifications we are to provide expansion joint cover assemblies, however, upon review of the drawings we unfortunately cannot locate this item. If this item is a requirement then please provide its location

- Q29. Please provide a specification for the recessed floor grille noted on drawing A101.
