The viewing sample shall be returned to the RCMP in the same condition as received by the manufacturer. Lost or damaged viewing samples shall be replaced by an identical item or the RCMP shall be reimbursed for the cost of an acceptable replacement.

PURCHASE DESCRIPTION

TAMPERPROOF EVIDENCE BAG, TYPE #2 (Non-Fire Debris)

1. **Definitions**

- 1.1 This purchase description shall govern the manufacture and inspection of "Tamper Proof Evidence Bag, Type #2 (Non-Fire Debris)" with a barrier design for use by Royal Canadian Mounted Police personnel for various types of samples including drugs and potentially hazardous materials, <u>but excluding fire debris</u>. The specific items covered under this purchase description with stock numbers are as follows:
 - i. 116973 Tamper Proof Evidence Bag, Type #2, Size A;
 - ii. 116975 Tamper Proof Evidence Bag, Type #2, Size B;
 - iii. 116981 Tamper Proof Evidence Bag, Type #2, Size C;
 - iv. 116984 Tamper Proof Evidence Bag, Type #2, Size D;
 - v. 116985 Tamper Proof Evidence Bag, Type #2, Size E;
 - vi. 116986 Tamper Proof Evidence Bag, Type #2, Size F.
- 1.2 This purchase description, or other information issued in connection therewith, may only be used for specific enquiries, solicitations, or orders placed on behalf of the Royal Canadian Mounted Police.
- 1.3 This purchase description supersedes all previous purchase descriptions for R.C.M.P. Tamper Proof Evidence Bag, Type #2 (Non-Fire Debris).
- 1.4 This purchase description has been translated into French from this original English language document.

2. **Applicable Specifications**

2.1 The following publications are applicable to this purchase description and to the issues in effect on the date of the solicitation, unless otherwise specified.

3. General Requirements

3.1 The article or material covered by this purchase description shall be free from imperfections or blemishes such as may affect its appearance or serviceability.

3.2 <u>Design</u> - Tamperproof Evidence Bag, Type #2 (Non-Fire Debris) shall be constructed of a clear nylon/polyethylene film with an adhesive-backed tamper-proof tape for closure. The nylon layer serves as a barrier to the transfer of volatile material. The polyethylene layer allows the bag to be heat sealed in addition be being sealed with the tamper-proof tape.

4 **Detail Requirements**

4.1 **Components**

- 4.1.1 **Film** The film shall be a two layer laminate using transparent nylon 6-6 film (19 micrometres thickness minimum) on the exterior with a low density polyethylene (76 micrometres thickness minimum) on the interior.
- 4.1.2 <u>Tape</u> The tape shall be an adhesive-backed tamper-proof tape 95 mm in width, \pm 3 mm. The adhesive shall perform in the temperature range of -30° C to +40° C.

Note: The adhesive-backed tape must be such that once the bag is sealed it cannot be opened, entered or have evidence removed from the bag without damage to either the plastic film of the bag or the tape.

- 4.2 <u>Construction</u> The bag or the material specified in Para. 4.1.1 shall be securely heat sealed, 10 to 13mm in width, across the bottom and both sides. The top shall be equipped with the tape specified in Para. 4.1.2, for closure. The tape shall be attached to one outer surface of the bag to a depth of 20 mm with the remaining 75 mm having a removable strip to protect the adhesive. Care shall be taken to ensure proper placement of the tape to ensure no appreciable gap forms between the adhesive backed label and the opening of the bag. Quality of workmanship shall be equal to the viewing sample.
- 4.3 <u>Tape Marking</u> Each bag shall have the following wording legibly and indelibly printed on the tamper proof tape, font Times New Roman, all capitals, letters 3 to 3.5 mm high:

Each bag shall have the manufacture date of the bag indicated on the tape label.

- 4.4 <u>Bag Marking</u> Printed across the bottom seal of the bag shall be the word "EVIDENCE" repeated across the entire width of the bag, readable from the same side of the bag as the label. The lettering shall be plain gothic type, dark blue in colour not less than 3 mm high. The printing shall be embedded between 2 layers of film and shall be readable from the same side of the bag as the label when sealed.
- 4.5 <u>Size</u> The bags shall be supplied in sizes as outlined below.
