Due to the technical nature of amendment 002, this amendment will be available in English ONLY.

Amendment 002 is raised to answer the following questions:

Question 1: As per drawing PEI-M1, there is a side view reference notation (at the top of the drawing) for 2/PEI-M1. It references: B/PEI-M2. However there is no HPU reference shown, nor is there detail as to the location of the HPU.

Answer to Question 1: The section is showing the exterior of the control booth.

Question 2: Is the HPU located indoors or outdoors?

Answer to Question 2: The HPU is located indoors per drawings 2/NS-M1 & 2/PEI-M1

Question 3: Expected temperature extremes for that location (indoors or outdoors).

Answer to Question 3: 35C summer and 10C winter

Question 4: Are there space constraints for the HPU envelope?

Answer to Question 4: The intent is to house the new HPU in the space occupied by the existing HPU which is approximately an 882x1530 (34.75"x60.25") footprint. The maximum allowable height of the unit is 2440mm (8').

Question 5: What are the expected environmental conditions at each site that the systems have to be designed to, Minimum & Maximum Operating Temperatures?

Answer to Question 5: Caribou Extreme Ambient Temperatures: 36.0C in August and -25.0C in December Wood Islands Extreme Ambient Temperatures: 34.4C in August and -28.1 in December

Question 6: Minimum & Maximum Storage Temperatures

Answer to Question 6: Caribou Extreme Ambient Temperatures: 36.0C in August and -32.5C in January
Wood Islands Extreme Ambient Temperatures: 34.4C in August and -30.5C in January

Question 7: In reference to #1 above, if the HPU is not in the control room, will it be subject to icing conditions and, if so, expected levels of precipitation.

Answer to Question 7: The HPU is indoors.

Question 8: None of the drawings show the width of the ramps. It is difficult to approximate quantity of required hydraulic tubing without such information.

Answer to Question 8: The transfer bridge is 9.1m wide, clear between HSS railings, with a 1.030m cantilevered walkway. The bridge (excluding the walkway) is centered between concrete abutments, spaced 11.854m apart, inside face. It should also be noted that the drawings are to scale referencing as-built drawings sheet 1-14 dated Jan. 1993.
