Could Canada confirm that under Section 5.1.1: 'grandfather clause' in the RFSA, that project references that were submitted in response to the last re-compete and deemed compliant by PWGSC as meeting the mandatory requirements; can be grandfathered so long as the other mandatory requirements are met for each stream and tier that a bidder is already qualified to provide service under?
