Les propositions ne respectant pas cette exigence seront rejetées.

Question 1:	Under General Requirements Item 6.1, construction period, it states work to be completed by January 22, 2016. In the Bid and Acceptance form it states February 22, 2016.
Réponse 1:	The work must be completed by February 22, 2016.
Question 2:	What is the anticipated start date for construction?
Réponse 2:	Work will commence after the tender is awarded and all documentation is completed and approved by the Contract Authority.
Question 3:	What is the ceiling height from floor to u/s of deck? Are the masonry walls to be demolished to u/s of deckif not what are their heights?
Réponse 3:	Block walls to be removed full height.
Question 4:	What is the height of the new drywall partitions, 8' or to u/s of deck?
Réponse 4:	New wall construction to u/s of ex. Structure.
Question 5:	Is there an asbestos concern in the facility?
Réponse 5:	Any asbestos that is required to be removed will be removed by owner supplied forces – Not part of this contract.
Question 6:	Regular working hours from 7am - 4pm for construction?
Réponse 6:	Correct.
Question 7:	Is there an electrical spec for this project?
Réponse 7:	All electrical work and specifications related to work is on the tender Drawings – No electrical Specification is issued.



- Question 8: Who are the base mechanical, fire alarm and electrical trades for the building?
- **Réponse 8:** Base Mechanical Fahrhall Mechanical and Lekter Mechanical Fire Alarm Contractor – Forest City Base Electrical – Delta Integrated building solutions
- Question 9: What is the specified tile for the floors and walls respectively? The spec says to match Phase A but doesn't list a product.
- **Réponse 9:** Tile specification for wall and floor tiles including grout colors:

Wall Tile – Floor to finish ceiling installation Tile: Santa Barbara – White 34020 – 10"x13"

Floor Tile Spectra (Small Grain) Nordic Light (Light Grey) 12"x12"

Grout Floor-Mapei-Pewter #02 Wall-Mapei-Biscuit #14

- Question 10: Please confirm that you are looking for a 5" front edge to the Corian countertop and a 3" backsplash.
- **Réponse 10:** The information noted related to the front edge and backsplash is correct.
- Question 11: Please clarify. Had a look at this and it looks like barrier free door operators are "kind of" spec'd under the hardware sec 08 71 00. It is a little confusing they have only itemized the activation switches and have not called for an actual door operator, but have called for manual closers. There is a note near the end of that section "noted all equipment to be supplied to ensure actuator is optional" not sure what that means
- **Réponse 11:** Barrier Free door operator and push button actuator is required on the door as noted E17 Note on Dwg A101 and as shown on the electrical drawing.
