SOLICITATION AMENDMENT No. 002

This solicitation amendment No. 002 is raised to:

1) amend the solicitation.

1) At Annex A, of the contract “**Statement of Work**”, under Article 4, “**Detailed Support Requirement**”,

Insert: 4.3 Canada will request within 5 calendar days after Contract award, that the Contractor must provide additional resources on an “as and when requested” basis from the identified labour categories listed in Table 2, which is over and above the required resources identified in Table 1. These additional resources are to accommodate a known surge in production that is anticipated to begin immediately after Contract award. These additional resources will be requested through the TA process detailed in the Contract and will be evaluated in accordance with Appendix 2 to Annex A.

Table 2: lists the required number of resources needed for the specific labour categories to accommodate a known surge in production. The breakdown between English essential and bilingual positions is also identified for each labour category. All pertinent labour category qualifications and experience requirements are contained in Appendix 1 to Annex A – Labour Categories.
