PART 1 – QUESTION AND ANSWER

Question 1

In table 2 here (page 38), what is "Extended price"? Can you please elaborate?

In Annex B, on page 37 of the RFP it states, "CRA has set a maximum ceiling annual price of \$25,000.00 for the yearly license subscriptions (excluding year 1 training, item 2, Table 1)." Can you please confirm whether or not this ceiling annual price of \$25,000 refers to the limit per subscription or is this the limit for all 8 subscriptions?

Question 3

In Section 4, on page 27 of the RFP it states, "The contractor shall provide unlimited access (surveys must be accessible 24/7, programming and editing capabilities must be available for a minimum of 12 hours during standard business hours) to an online survey tool that will be used by for up to (8) eight users within Public Affairs Branch that allows for the creation of CRA-branded public opinion surveys. At least one account will have full user based administration rights with the ability to assign full admin rights to the other users." As CRA is asking for us to price this project on the basis of a per unit price for each subscription, can you please confirm that a minimum of 8 subscriptions can be assumed for our pricing?
