This amendment is issued to distribute answers to bidder questions.

BIDDER QUESTION

Q1 Is the bridge vehicular accessible for the work or is it a hike (if a hike, about approximately how long and how much elevation change)?

A1 There is vehicle access to the bridge but only on the west side.

Q2 The mandatory site visit on Thursday is “meet at the compound”. Are we then hiking to the bridge? If so approximately how long would this take?

A2 We will drive to the bridge site after the bidders have had an opportunity to review the existing steel bridge stored in our yard. Walking for this site visit will be minimal.
