NOTE: Bidders' clarification questions are numerically sequenced upon arrival at SSC. Bidders are hereby advised that questions and answers for this solicitation may be issued out of sequence.

Bidder Question 1	Pricing – Reference Pages Annex B – There are no quantities listed in this RFP but there is a weighting factor. The weighting factor seems to perform the calculations like quantity – is the weighting factor the quantities?
Canada's Response to Question 1	The weighting factor listed in Annex B1 and B2 can be considered as projected quantities, however, Canada's obligation under the Contract is limited to Minimum Work Guarantee stated in Part 7 – Resulting Contract Clauses. Weighting factor is provided for evaluation purposes only, in order to assist the bidders in preparing their bids.
Bidder Question 2	Pricing long term. How do we approach the subject of the fluctuating exchange rate over the 3 years + contract period? Will a clause for currency fluctuations be considered?
Canada's Response to Question 2	The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids that include such provision will render the bid non-responsive.
Bidder Question 3	What is the required delivery date for the product? (relative to question 1)
Canada's Response to Question 3	Canada's intent is to issue a small order (up to 12 items) using a Requisition on Contract (ROC) on an "as-and-when-requested basis", soon after contract award in order ensure the products meet the contract specifications. The delivery will be required within a 2-week period from issuance of the ROC. A subsequent order for a larger quantity may be issued in January-February 2016, assuming the contract is awarded, and delivery will be in mid-March 2016. Order details including schedule will be agreed as per the ROC.
