## **DRAWINGS**

### **ANSWERS TO QUESTIONS**

1. **QUESTION**

The Tender Documents indicates the job is to be completed by March 31, 2017, however the notes on the drawings seem to contradict that. For example the drawings state that the work in Northport starts after April 1, 2016 and must be completed by July 17, 2016 due to the fishing season - that is the time frame that the fishing season would actually be active at that wharf which would make it difficult to work around. Also the drawings state Naufrage begins after the award and must be complete by March 31, 2016.

Could you clarify what the expected timelines are in regards to the working schedule of these two locations?

**ANSWER**

Drawing M1 of 3

**Delete:** Note 'Scheduling of Work' - as shown highlighted by 'box' enclosure.

**Replace with:** All work for both locations to be complete before March 31, 2017. Contractor to schedule work at both locations around local Harbour Authority requirements and fishery activity.

2. **QUESTION**

On the drawing M2, it states that the approximate length of SSP to be repaired is 154 meters (U section 92 m and Z section 62 m). The volume of material estimated on the unit bid sheet however, seems to be consistent with 184 meters of repair (this would seem to represent the total linear meters of the structure ( U section 92m, Z section 62 m and the 30 meters not being repaired). Please advise.

**ANSWER**

Repair length of SSP is to be 154 meters.
