## **AMENDMENT 05**

The purpose of this amendment 05 is to publish Questions and Answers regarding the Request for proposal (RFP) and to modify the Attachment 1.

Questions and Answers from 1 to 15 are part of previous amendments.

### **Questions and Answers**

**Q16:** As mentioned in the solicitation document, the supplier is requested to provide KANTECH access controllers. It seems that KANTECH access controllers are already on site. Does this mean that the KANTECH access controller(s) already on site are Underwriters' Laboratories of Canada (ULC) compliant? After verification, the KANTECH controllers are not ULC-compliant.

**A16:** As mentioned in the Annex A « Requirement », section 5.A:  
"The components and the installation must be ULC-compliant (Underwriters' Laboratories of Canada)".

The information related to the ULC norms has been inserted in the wrong section of the Annex A « Requirement ». This information should have been inserted in the section 5.B "Anti-intrusion alarm system and panic button system". This correction will be made in the resulting contract.

The KANTECH equipment does not have to be ULC-compliant. The answer A15 published in Amendment 03 was incorrect.

The installation of the anti-intrusion alarm system, more precisely the connection with end of line resistors, must be done in accordance with the ULC specifications.

**Q17:** Do suppliers need to have a permit issued by the Bureau de la sécurité privée (BSP)?

**A17:** This is not required as part of this Request for proposal.
