SOLICITATION AMENDMENT No. 003

This solicitation amendment No. 003 is raised to:

- 1) publish answers to questions that have been received in relation to this solicitation; and
- 2) amend the solicitation.

1) The following provides answers to questions received:

QUESTION 1:

Please refer to Appendix 1 – Annex A – Labour Categories, specifically Labour Category 4 – ACS Course Instructor (pg. 41), Mandatory Qualifications, 2; Canadian Forces – Trained Personnel. Would the Crown accept Aircraft Life Support Equipment (ALSE) as part of the ACS Course Instruction?

- a. Qualified ACS (or QL 5 trade level for pre -1996 equivalent);
OR
Qualified to a minimum of the QL 5 Journeyman level with experience instructing ALSE,
and
- b. An ACS Course Instructor must have knowledge of and ability to apply principles of training delivery, demonstrated through work experience in a training environment as an instructor where the resource prepared and delivered lessons in the context of aircraft maintenance training using established lesson plans approved by a technical institute.

ANSWER 1:

For Labour Category 4, Mandatory Qualification, Education Qualifications and Experience, 2. a., Canada will not accept the proposed change. The requirement for the proposed resource to be ACS trained is critical to the requirement.

QUESTION 2:

Please refer to Appendix 1 – Annex A – Labour Categories, specifically Labour Category 7 – AVN Course Instructor (pg. 47), Mandatory Qualifications, 2. Canadian Forces – Trained Personnel.

- 2. a. For Canadian Forces – Trained Personnel, a. Qualified AVN (or QL5 trade level for pre – 1996 equivalent).

For those individuals who have been given aeronautical training by another military organization such as the British Army, British Air Force or the United States Air Force, would the Crown considered the following to be equivalent to a QL 5 trade level. Please confirm that this is still acceptable:

- Supervisor Technician Training Aeronautical Engineering, Royal Electrical and Mechanical, Engineers, British Army (who have responsibility for aircraft maintenance);
- US Equivalent R3, US Air Force; and
- Engineering Technician, Aircraft Electrical, British Air Force.

ANSWER 2:

For Labour Category 7, Mandatory Qualification, Education Qualifications and Experience, 2.a., Canada will accept the above proposed training from the proposed military organizations as QL5 trade level for pre-1996 equivalent.

QUESTION 3:

Please refer to Appendix 1 – Annex A – Labour Categories, specifically Labour Category 12 – AVS Technician (pg. 57), Mandatory Qualifications, 1. For Civilian- Trained Personnel and 2. For Canadian Forces – Trained Personnel.

1. b. and 2. b. A qualified instructor with at least two (2) years of teaching experience.

Please confirm that this experience has been included as an oversight and should be removed from this labour category, as this experience is not a requirement of any of the other Technician labour categories.

ANSWER 3:

This experience should be removed from Labour Category 12 – AVS Technician. The deletion of this experience will be made through solicitation amendment 003.

QUESTION 4:

Please refer to Appendix 1 – Annex A – Labour Categories, specifically Labour Category 16 – E-Learning Flash Developer (pg. 64), 1 – for Civilian-Trained Personnel.

1. a. Successful completion of a two (2) year of a College level educational program in web-based development of courseware, computer modeling and animation, computer science, information technology or equivalent.

In the previous RFP (#W0113-13CS03/A), the final wording specified "...or an acceptable combination of education, training, and/or experience." As this would not be a precedent, the bidder respectfully requests that this requirement be modified to reflect the wording of the last RFP.

ANSWER 4:

The final wording specified "...or an acceptable combination of education, training, and/or experience." will not be included into solicitation W0113-14CS31/B. However, Canada will accept candidates with additional experience that will be advised through solicitation amendment 003.

QUESTION 5:

Please refer to Appendix 1 – Annex A – Labour Categories, specifically Labour Category 19 – Instructional Design Officer (pg. 70), 1. - for Civilian-Trained Personnel.

1. a. Undergraduate or post-graduate degree in or specializing in Education or Distance Learning offered by a recognized institution;

As previously stated and accepted by the last RFP (#W0113-13CS03/A, Amendment #3), a candidate who possesses a B.Sc degree in Business Administration, coupled with a Teacher's certificate was deemed to be acceptable. Please confirm that this is still acceptable.

ANSWER 5:

For Labour Category 19, Canada will not accept the proposed qualifications as stated, however Canada will accept candidates with additional educational qualification that will be advised through solicitation amendment 003.

QUESTION 6:

Please refer to Annex A, Statement of Work, 4. Detailed Support Requirement, Table 1 (pg. 31) where the estimated number of AERE Course Instructors required is one (1) and the estimated number of AERE Standards Designers is two (2). Please confirm if this is correct.

ANSWER 6:

The above requirement is correct.

Educational Qualifications and Experience:

The essential minimum qualifications for an AVS Technician include:

1. For Civilian-Trained Personnel:
 - a.
 - (i) Graduation from an Avionics Maintenance Technician program offered by a technical institute that is recognized by the Canadian Council for Aviation & Aerospace (CCAA) in the delivery of one or several accredited programs and three (3) years of experience as an Avionics Maintenance Technician in an aircraft maintenance organization; or
 - (ii) Graduation from a program offered by a technical institute that is recognized by Transport Canada (TC) as an Approved Training Organization (ATO) and three (3) years of experience as a registered Aircraft Maintenance Engineer (E rating) in an aircraft maintenance organization.

OR

2. For Canadian Forces-Trained Personnel:
 - a. Qualified AVS (or QL 5 trade level for pre-1996 equivalent).

Delete: Mandatory Qualifications – Educational Qualifications and Experience section, in its entirety, and

Educational Qualifications and Experience:

The essential minimum qualifications for an E-Learning Flash Developer include:

 - a. Successful completion of a two (2) year of a College level educational program in web-based development of courseware, computer modeling and animation, computer science, information technology or equivalent.

OR

- b. Four (4) years of work experience in the development of courseware, computer modeling or animation, in the last eight (8) years

Delete: Mandatory Qualifications, the Educational Qualifications and Experience section, Article 1, in its entirety, and

Insert: 1. For Civilian-Trained Personnel:

a.

- (i) Undergraduate or post-graduate degree in or specializing in Education or Distance Learning offered by a recognized institution;

OR

- (ii) Post-secondary degree and has completed a Teacher Education Program that is recognized by the applicable provincial standards organization (e.g. Ontario College of Teachers in Ontario).

- b. Two (2) years minimum full-time instruction in adult education-related employment; and
- c. Two (2) years experience in Design, Development and implementation of Instructional programs and Distributed Learning.
