A12:

The term "affiliate" as it relates to article 5.1.5, Certification of Formal Arrangement related to Mandatory Requirement M.3, means an incorporated company within its corporate family that operate on a co-ordinated basis across multiple jurisdictions with respect to a common brand, deployment of human resources and use of technical knowledge and experience.
