AMENDMENT 002

This amendment is issued in response to the following:

1. Under bid closing:

2. The following bidder questions are answered below:

Question 1: Regarding product #5, a 30 x 78 size is not available in a counter balance table due to stability concerns. 30 x 72 is the maximum size. Are we able to provide a 30 x 72 in the requested mechanism, or failing that, the proper 30 x 78 size in an electric height adjustable mechanism?

Answer 1: For product #5, 30 x 72 is not an acceptable replacement for 30 x 78.

Question 2: I have a question concerning the delivery dates of items 1 to 5. On paper, it is noted that these tables are supposed to be delivered for December 7 (date to be confirmed). Basically, I was wondering if this date was exact or if there has been a change?

Answer 2: Tentative delivery date for items 1 to 5 is being changed to January 4, 2016. Exact delivery will be determined after contract award.

Question 3: I have just read the addendum and want to be sure I have this correct. The original tender does not want electric or crank base. It has to be a height adjustable table that is not powered, although you can substitute the 36" x 24" with an electrical mechanism.

Answer 3: All tables are to have the same method of operation. Either electric, gas lift, counter balance or other pressure sensitive movement.

Question 4: For installation, is there an elevator available or would this be stair carry? I assume there is no loading dock so this would have to be taken in through public entrance and off handed from the truck.

Answer 4: There is an elevator on site. There is no loading dock. Product will have to be hand bombed from truck.

Question 5: The tender closes November 25, but a tentative delivery date is December 7 for items 1 through 5....is this correct?

Answer 5: Tentative delivery date has been changed. See answer 2 above.

All other terms and conditions remain unchanged.
