Shift Report:

1700 – Shift Start. Drove to Tempo to fill car with gas. Continued on to Campground to do a walking tour. Stopped at Kiosk - 249 Campers registered with 15 reservations still to come, and no flagged sites by Parks Canada staff.

1730 - Walked serviced sections 1-86 and 101 - 173. Finished at 1915. Patrolled remaining areas of campground on bike. Finished at 2015.

2015 – Driving tour of Townsite. Drove all roads and backlanes. Checked Boat Cove, Boat Storage, Old Campground, Big Parking Lot, RCMP grounds . Finished Townsite tour at 2045.

2045 – Driving tour of Campground in search of unattended coolers. Drove all sections.

2055 – Removed one blue cooler from site #102. Left a Bare Campsite Program, Tent tag and instructions on where to retrieve their cooler. Took cooler to Kiosk.

2100 – Attempted to remove one blue cooler from site #215 but the campers returned in the process. We explained the Bare Campsite Program to them and the campers agreed to comply and store the coolers when unattended.

2125 – Removed one blue cooler from site #414. Left a Bare Campsite Program, Tent tag and instructions on where to retrieve their cooler. Took cooler to kiosk. Finished Campground tour at 2200.

2200 – Driving tour of Townsite. Drove all roads and backlanes. Checked Boat Cove, Boat Storage, Old Campground, RCMP Grounds and all fringe sites. Finished at 2230.

2230 – Driving tour of Campground. Drove all sections. Finished at 2300.

2300 – Walking tour of Townsite. Walked down Columbine, Wasagaming, Tawapit, Heritage, Mooswa and Buffalo. Checked Beach area, Band Stand, Pier, Martese, Admin Building, VC Building and Cookshack. Finished at 2355.

2355 – Checked Deep Bay. All secure. Finished at 0005.

0005 – Driving tour of campground. Drove all sections.

0042 - Received a noise complaint from Jasper dispatch about site #399. Reported to site and spoke to campers about noise levels and quiet hours. Campers complied. Finished at 0050.

0050 – Arrived at Kiosk to fill out Shift report log details.

0110 – S/Os off duty
