Modification 1

ANNEX B - BASIS OF PAYMENT – of the RFSO is amended as follows :

Delete : "Backhoe with jackhammer"

Insert : "Backhoe with jackhammer (or excavator with jackhammer)"

Delete : "Compactor "

Insert : "Compactor, with a minimum compaction force of 8000 lbs"

Delete : "Excavatrice (max. 1.7 tons)"

Insert : "Excavator (max. 1.8 tons)"

Question 1

Can you clarify the "Machinery" section of the Basis of Payment:

- 1(a) At item 13 "Backhoe with jackhammer", our subcontractor do not use jackhammer on the backhoe. Only on an excavator. Do we put the price of the excavator with jackhammer?

Answer: Machinery (excavator with jackhammer) is accepted.

- 1(b) Item 15 : Is the trailer for the backhoe or for an excavator ?

Answer: The trailer is for any use, as transporting machinery and/or objects such as concrete blocks. Everything the delivery truck (F-150 or Cube) cannot run.

Warning: Machinery rates are from the time you start work on the premises. The transport must be included in your rate.

- 1(c) Item 17 "Compactor". Is it a roller or a vibrating plate??

Answer: Compactor, model with a minimum compaction force 8000lbs

- 1(d) Item 20 "Excavator (max. 1.7 tons)". According to my subcontractor, it is a mini excavator. Is that what you need?

Answer: Correction, Excavator (max 1.8 tons). We expect to receive a price for a model Kubota KX018-4 or similar.
