PART 1 - GENERAL INFORMATION

1.1 Requirement

The Department of National Defence (DND), National Air Force Museum of Canada (NAFMC), CFB Trenton has a requirement for one (1) machine shop lathe for use in an aircraft workshop for fabrication, modification, adjustment and repair of aircraft parts. This requirement is a replacement for an existing lathe that has reached its end of life, and must fit within the existing space.

The requirement includes on-site equipment installation and 1 training session on the operation of the equipment.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT).

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2015-07-03) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than **ten (10)** calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

Section I: Financial Bid (1 hard copy)

Section II: Certifications (1 hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Financial Evaluation

To be responsive the Bidder must:

- 1) Provide Firm Unit prices for **all** items listed in Annex B – Basis of Payment.

The Bidder's Firm Unit Prices will be multiplied by the quantity to calculate the extended Firm Unit Pricing. The evaluated price is total of all Extended Firm Unit Price(s).

4.2 Basis of Selection

- 4.2.1** A bid must comply with all requirements of the bid solicitation to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

1.0 OVERVIEW

The Department of National Defence (DND), National Air Force Museum of Canada (NAFMC), CFB Trenton has a requirement for **one** (1) machine shop lathe for use in an aircraft workshop for fabrication, modification, adjustment and repair of aircraft parts. This requirement is a replacement for an existing lathe that has reached its end of life, and must fit within the existing space. The requirement includes on-site equipment installation and 1 training session on the operation of the equipment.

2.0 DELIVERABLES

The Contractor must deliver the following:

- (a) Quantity **one** (1) Machine Shop Lathe in accordance with the requirements at Section 3.1;
- (b) Installation as follows:
 - i. Delivery to the DND location;
 - ii. Unpack and set-up;
 - iii. Set-to-work to ensure all systems/components are functioning correctly; and
 - iv. Removal and disposal of all packing material;
- (c) A one (1) day Familiarization training for up to 3 NAFMC personnel prior to March 24th, 2016 as per arrangements taken with Technical Authority; and
- (d) Operator/Maintenance Manuals in accordance with Section 2.1.

2.1 Operator/Maintenance Manuals

The Contractor must provide operator/maintenance manuals, in English, to DND as follows:

- (a) One (1) hard copy and one (1) electronic copy (MS Word or PDF format) of the Operators Manual that includes illustrated operating , safety and user maintenance instructions; and
- (b) One (1) hard copy and one (1) electronic copy (MS Word or PDF format) of the Maintenance Manual that includes all first and second line repairs of the device with an illustrated parts lists in a top-down breakdown format with the following information for each item:

 - iii. Infinite speed control between 100 and 3500 RPM (minimum);
 - iv. Distance between centers of no less than 2000 MM (80");
 - v. Swing over bed of no less than 406 MM (16 in);
 - vi. Variable rate power carriage and cross slide feeds;
- (b) Have the following features:
 - i. CSA approved for operation on external power as follows:
 - a. Primary: 220 VAC, 3 Phase, 60 Hz for drive motors; and
 - b. Secondary: 110 VAV, Single Phase, 60 Hz for controls;
 - ii. Min 10 HP AC inverter spindle motor;
 - iii. Hardened and ground alloy steel tool bed;
 - iv. Full bearing carriage with a low friction coated slideway (Turcite B or equivalent);
 - v. Coolant system;
 - vi. Worklight;
 - vii. Lead screw stop;
 - viii. Lever action collet closer; and
 - ix. Spindle brake;

 - ii. Width: 1219 mm (48");
