2.2.1 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least **7** days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than **seven (7)** calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in **Prince Edward Island**.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

ANNEX "A"

STATEMENT OF REQUIREMENT

Statement of Requirement: Laboratory Size Gravity Table:

There is increasing interest in growing non-traditional grains and oilseeds in Atlantic Canada. These crops vary significantly in seed size compared to conventional grains and oilseeds. Although traditional planting and harvesting equipment may be used, specialized post-harvest seed cleaning equipment is needed.

Examples of these crops include fava bean (very large seed) and canola or quinoa (very small seed). Although this seed can be cleaned using conventional methods (screening by size) up to a point, in order to obtain the highest quality of seed from research plots the seed must be separated according to density. For example in larger seeded pulses, poorer quality seed may retain its size but would not have the same internal structures, therefore the density would be lower and the seed itself would be of lower quality. For smaller seeds, seed purity is an issue whereby green seed or weed seed contaminates higher quality seed. Density separation is the best course of action for this problem.
