QUESTIONS AND ANSWERS

- Q4.** When you state that DND will provide in-town meals, can you clarify specifically what days and meals these are?
- A4.** *The Contractor is expected to cover all meals from 14-23 February during the 10 day Expedition. All meals on 12-13 February and 24 February will be covered by DND.*
- Q5.** Scope of Work 1 (i) states that there should be a full day of cultural activities at the end of the expedition but that is not shown as allowed for with the expedition day 10 as the last full day in the itinerary before the team flies out. We are planning for Day 10 to be a full expedition day and do not see where time would permit for a full cultural day.
- A5.** *The cultural day may be completed Saturday 13 February in conjunction with the prep day or Wednesday 24 February as the group does not depart the Punta Arenas Airport until 16:15 hours.*
