## SOLICITATION AMENDMENT No. 007

This solicitation amendment No. 007 is raised to:

- 1) publish answers to questions that have been received in relation to this solicitation; and
- 2) amend the solicitation

- 1) The following provides answers to questions received:

### QUESTION 1:

*The Bidder respectfully request that the clause at Annex D, Insurance Requirements, c) All Risk Property Insurance be removed.*

*The Bidder's concern is that for Crown owned facilities there are typically a number of CF, Public Service and other contractors' personnel occupying the property in question while under the contractor's custody or control (of the property). Asking the Bidder for a "Waiver of Subrogation Rights" stating that it waives all rights of subrogation against Canada as represented by DND and PWGSC for any and all loss of or damages to the property **however caused** would require the contractor to have control over other non-contractor personnel within the property, which is not possible (no employer-employee relationship).*

*However, if the Crown feels justified in maintaining this clause, we respectfully request that it be modified as follows:*

*(C) All Risk Property Insurance*

*Introductory paragraph – "The Contractor must obtain All Risks Property insurance .... The Government's Property must be insured on Replacement Cost **OR (vs. and)** Actual Cash Value basis."*

*(i) no exception taken – acceptable as worded*

*(ii) a. and b. no exception taken – acceptable as worded,*

*c) Waiver of Subrogation Rights: remove completely for reasons as stated above.*

### ANSWER 1:

Canada will not accept the proposed qualifications as stated above. However, Canada will make changes to the clause that will be advised through solicitation amendment 007.

### QUESTION 2:

*Refer to Annex D*

*In the event that All Risk Property insurance is indeed required, please provide a description of the CFSATE facilities and equipment to be covered by the All Risk Property Insurance Requirement, in sufficient detail to allow us to obtain an accurate quotation for the policy from our insurance broker.*

### ANSWER 2:

The CFSATE equipment to be covered by the All Risk Property Insurance is as follows:

- 8 purpose-built developer stations; and
- 79 regular stations (laptop, docking station, 2 X monitors, accessories)

2) Solicitation amendments:

2a) At Annex D – Insurance Requirement, of the contract,

**Delete:** Article (c) All Risk Property Insurance, in its entirety, and

**Insert:** **All Risk Property Insurance**

The Contractor must obtain All Risks Property insurance while the Government Property is under its care, custody or control, and maintain it in force throughout the duration of the Contract, in an amount of not less than \$222,000.00. The Government's Property must be insured on Replacement Cost basis.

- (i) Administration of Claims: The Contractor must notify Canada promptly about any losses or damages to Government Property and monitor, investigate and document losses of or damage to ensure that claims are properly made and paid.
- (ii) The All Risks Property insurance policy must include the following:
  - a. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority at least thirty (30) days written notice of policy cancellation.
  - b. Loss Payee: Canada as its interest may appear or as it may direct.
  - c. Waiver of Subrogation Rights: Contractor's Insurer to waive all rights of subrogation against Canada as represented by the Department of National Defence and Public Works and Government Services Canada for any and all loss of or damage to the property however caused.

**ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED**
