This Amendment 003 is raised to respond to questions from bidders.

Responses to Questions from Bidders

Q1. Will the Harbour Authority coordinate moving of the boats to facilitate the dredging?

A1. The Harbour Authority will coordinate the moving of all boats

Q2. How many float bays will be open and available for dredging at any one time?

A2. 4 bays at a time will be open

Q3. Has the sediment been tested for salt content (Na, Cl)?

A3. The samples were not tested for NaCl.

NaCl is not typically included in the suite of contaminants tested for because:

1) samples containing contaminant levels that meet Disposal at Sea requirements are being delivered to a receiving environment with NaCl (sea water).

2) samples containing contaminant levels that DO NOT meet Disposal at Sea requirements are being delivered to a hazardous waste facility where NaCl levels associated with sea water are of little or no concern.
