| 1 | We have a current Standing Offer Agreement to provide Geotechnical Engineering and Materials Testing Services in Ontario Region, which were to be provided in support of various PWGSC projects on behalf of Parks Canada. While this SOA is nearly 2 years old with only one year remaining, we have had only one call-up to date, which we now understand may have been due to delays as Parks Canada and PWGSC was getting approval and funding for the delivery is new very large and ambitious undertaking to rehabilitate the Ontario Waterways infrastructure. The amount of work we have completed to date is well below that which we anticipated under this SOA, and we have the capacity and experience to do much more than this. We remain ready and willing to carry out more geotechnical engineering and materials engineering assignments to support design under your current program; we would also be prepared to discuss extending our SOA for additional years so that you don't need to go through another RFP process for our type of services during the critical period between now and April 2017 when the construction work proceeds in earnest. | Standing Offers call-ups are issued on a fair and transparent computer-controlled rotational basis as the need for service arises. Subject to the terms and conditions of the Standing Offer, PWGSC will evaluate its options to extend the Standing Offer end date or opt to issue a new Request for Proposal. |
| 2 | Since the Parks Canada project is using federal money I assume that Transport Canada's Floating Plant Clause will be included in the specified requirements. Please see PWGSC form 2843. | Form 2843 or the Floating Plant Clause will be considered for inclusion as appropriate based on specific project requirements. |
| 3 | You mentioned that your intention was to go out with tenders in design and construction management. Our question is: If some parts of the works could be execute by the Construction Management or not. | This is under review and the CM may be able to price some of the work to perform by its own forces for PWGSC's consideration. |
| 4 | Have you any idea at this time the value of each Construction Management bundle? | The all-inclusive budgets range from \$20 M to \$160 M including construction cost, various consulting services, as well as internal costs. |
