## PART 1 - GENERAL INFORMATION

### 1.1 Requirement

The Department of National Defence (DND), Influence Activities Task Force, CFB Kingston has a requirement for the supply of **nine** (9) inflatable projection theatre screens to screen video as per specifications and components described herein.

### 1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### 1.3 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT).

## PART 2 - BIDDER INSTRUCTIONS

### 2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2015-07-03) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

### 2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than **ten (10)** calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

### 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## **PART 3 - BID PREPARATION INSTRUCTIONS**

### **3.1 Bid Preparation Instructions**

Canada requests that Bidders provide their bid in separately bound sections as follows:

Section I: Financial Bid (one (1) hard copy)

Section II: Certifications (one (1) hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

## **PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**

### **4.1 Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

#### **4.1.1 Financial Evaluation**

To be responsive the Bidder must:

- 1) Provide Firm Unit prices for **all** items listed in Annex B – Basis of Payment.
- 2) Not alter the format of the Basis of Payment in Annex B.

The Bidder's Firm Unit Prices will be multiplied by the quantity to calculate the extended firm Unit Price. The evaluated price is total of all Extended Firm Unit Price(s).

### **4.2 Basis of Selection**

- 4.2.1** A bid must comply with all requirements of the bid solicitation to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

## **PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION**

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

### **5.1 Certifications Required with the Bid**

Bidders must submit the following duly completed certifications as part of their bid.

#### **5.1.1 Declaration of Convicted Offences**

## Inflatable Projection Screen

### 1.0 REQUIREMENT

The Department of National Defence (DND), Influence Activities Task Force, CFB Kingston has a requirement for the supply of **nine (9)** inflatable projection screens to screen video as per specifications and components described herein.

### 2.0 BACKGROUND

These Outdoor theatres will be used to support PSTC courses, outfit the IA Companies across Canada, major exercises like the upcoming MAPLE RESOLVE, as well as operations such as stability operations. Outdoor theatres are an excellent force multiplier for influence activities. With them, we gain the ability to disseminate audio video products to a large amount of people indoors or outdoors regardless of most weather conditions.

### 3.0 DELIVERABLES

The Contractor must provide nine (9) Inflatable Theatre Screens containing the following minimum mandatory specifications and/or performing the following functions:

- I. Minimum Display Screen Size: 20ft (6.1m) width x 10ft (3.05m) height
- II. Minimum Screen Surface from ground: 5ft (1.52m)
- III. Must inflate, deflate and be constructed with long-lasting tear, puncture resistant and airtight construction material. Display screen must be stable and wrinkle free.
- IV. Must be able to be used as both a front projection and rear projection screen depending on situational need.
- V. Must be able to be erected on the following surfaces without damage to equipment. (grass, gravel, mud, concrete, pavement and snow)
- VI. Portable: screen must be easily transported by two individuals.
- VII. Must be Weather resistant: ability to be used outdoors in all conditions (sun, rain, snow, and wind) without damaging equipment or voiding warranty.
- VIII. Blower less operation once inflated. Projection screen must be able to maintain its shape and functionality without the use of a blower once initially inflated.
- IX. Must have adjustable anchoring system.
- X. Must come with Heavy duty storage bag or Heavy duty storage case for transportation.
- XI. Each screen must come with (2) High pressure blowers to inflate screen. One (1) electric plugin (110v) and one (1) cordless w/charger and 2 batteries.
- XII. Service and Repair Kit (extra supplies to prevent down time in case of air leak, cleaning supplies, etc.)
