2	PART 7, Section 24 - (p. 39 of RFP)	Transition Services at the End of Contract Period	<p>The contractor will not be providing a solution on a fixed price basis but rather providing a pool of resources on a T&M basis (as per the Basis of Payment) to assist customer in maintaining its applications.</p> <p>In light of this contractual arrangement that only provides for the recovery of costs based on consultant time in task authorizations, would the Crown please amend the above clause to clarify that the transition services at the end of contract period will be subject to a task authorization.</p> <p>This will provide for reasonable recovery of costs by the Contractor for transition requirements determined by the Crown.</p>	2	Canada has considered the request; modifications are provided in Section 2 below.
