AMENDMENT 003

This amendment is raised to answer bidder questions posed as of December 9th, 2015:

Question 8: I'd like to confirm exactly what address our bid submissions should be shipped to for Solicitation No. B8830-160322/A.

Answer 8: Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place, indicated on page 1 of the bid solicitation at the top left-hand corner of the page.

Question 9: The solicitation states that a goal is to close the gap between the 68,000 international youth who come to Canada and the 18,000 Canadians who travel outside Canada. Given that foreign youth come to Canada from 32 different countries (an average of 2,100 per country) vs the 18000 Canadians, does this mean that Canadians are nine time more likely rather than 3 times less likely to go abroad? Are we interpreting this information correctly?

Answer 9: The ratio is about 3.5 young people coming to Canada to 1 Canadian traveling abroad.

Question 10: Is there a detailed profile of existing/active program participants?

Answer 10: No.
